<b>HB 618</b>	<b>FLAVIN</b>	<b>INSURERS/AGENTS:</b> Specifies the manner in which an agent may obtain information from an applicant
<b>HB 691</b>	<b>FARRAR</b>	<b>INSURERS/ALIEN:</b> Increases the deposit and bond required of foreign and alien insurers
<b>HB 705</b>	<b>HAMMETT</b>	<b>INSURANCE/LIABILITY:</b> Requires homeowners' liability insurance to cover all-terrain vehicles used on or off premises
<b>HB 725</b>	<b>BOWLER</b>	<b>INSURANCE/POLICIES:</b> Provides for the conditions for cancellation, non-renewal, and increase of premiums and deductibles of certain property, casualty, and liability policies
<b>HB 767</b>	<b>BOWLER</b>	<b>INSURANCE DEPARTMENT:</b> Changes the makeup of the Louisiana Property and Casualty Insurance Commission
<b>HB 841</b>	<b>ANSARDI</b>	<b>INSURANCE/HEALTH-ACCID:</b> Provides for the method of delivery of health and accident insurance policies
<b>HB 889</b>	<b>FAUCHEUX</b>	<b>INSURANCE:</b> Restricts the printing of power-of-attorney of an insurer
<b>HB 1039</b>	<b>WINSTON</b>	<b>INSURANCE:</b> Repeals prohibitions on group insurance for property and casualty insurance
<b>HB 1113</b>	<b>FAUCHEUX</b>	<b>INSURANCE:</b> Adds provision for surrenders for non-payment of premium
<b>HB 1209</b>	<b>CAPELLA</b>	<b>INSURANCE DEPARTMENT:</b> Provides penalties for the failure of a dental referral plan to register with the Department of Insurance
<b>HB 1219</b>	<b>TUCKER</b>	<b>INSURERS/GUARANTY ASSNS:</b> Provides for disposition of unclaimed property held by the Louisiana Insurance Guaranty Association
<b>HB 1444</b>	<b>HEBERT</b>	<b>INSURERS:</b> Provides for loaning of securities by domestic insurers to members of the National Association of Securities Dealers
<b>HB 1445</b>	<b>HEBERT</b>	<b>INSURERS:</b> Authorizes domestic insurers to invest in bonds and obligations that are payable from the tax revenues of state, local, and federal entities

<b>HB 1466</b>	<b>HEBERT</b>	<b>INSURANCE/HEALTH:</b> Redesignates "franchise" coverage to "association" coverage
<b>HB 1477</b>	<b>HEBERT</b>	<b>INSURERS:</b> Provides for matters necessary for a certificate of authority for foreign and alien insurers
<b>HB 1508</b>	<b>HEBERT</b>	<b>INSURANCE DEPARTMENT:</b> Provides for the organization and functions of the office of property and casualty in the Department of Insurance and the Louisiana Insurance Rating Commission
<b>HB 1509</b>	<b>HEBERT</b>	<b>INSURANCE:</b> Provides that the Insurance Code is Title 22 instead of Chapter 1 of Title 22
<b>HB 1511</b>	<b>HEBERT</b>	<b>INSURANCE/SURPLUS LINE:</b> Deletes March 31st as the expiration date for surplus line brokers' licenses
<b>HB 1512</b>	<b>HEBERT</b>	<b>INSURANCE CLAIMS:</b> Requires insurers to provide proof of loss forms to persons claiming a loss under a contract of insurance
<b>HB 1612</b>	<b>TOWNSEND</b>	<b>INSURANCE/HEALTH:</b> Requires that pharmacy benefit managers be licensed and regulated by the Department of Insurance
