| <b>HB 138</b>  | <b>TRICHE</b>    | <b>RETIREMENT/STATE EMPS:</b> Provides for early retirement of LASERS members with actuarial reduction of benefits; requires abolition of positions vacated by early retirement and permits reestablishment only as provided in Act |
| <b>HB 410</b>  | <b>McVEA</b>     | <b>RETIREMENT/STATE EMPS:</b> Provides for a member to purchase directly from LASERS prior service credit in another system rather than repaying refunded contributions   |
| <b>HB 580</b>  | <b>DANIEL</b>    | <b>RETIREMENT/SCHOOL EMPS:</b> Prohibits the conversion to membership credit of sick and annual leave of less than one-tenth of a year  |
| <b>HB 758</b>  | <b>DANIEL</b>    | <b>RETIREMENT/SCHOOL EMPS:</b> Restricts reenrollment in the system by a former DROP participant who leaves employment for more than 30 days  |
| <b>HB 866</b>  | <b>BEARD</b>     | <b>RETIREMENT/STATE EMPS:</b> Provides for the purchase of service credit in the Louisiana State Employees' Retirement System by certain former nonpublic school teachers   |
| <b>HB 903</b>  | <b>SCHNEIDER</b> | <b>RETIREMENT/MUNICIPAL EMP:</b> Allows repayment of withdrawn contributions by a trustee-to-trustee transfer of funds  |
| <b>HB 904</b>  | <b>SCHNEIDER</b> | <b>RETIREMENT/SCHOOL EMPS:</b> Authorizes purchase of service credit for employment by out-of-state school boards   |
| <b>HB 905</b>  | <b>SCHNEIDER</b> | <b>RETIREMENT/SCHOOL EMPS:</b> Authorizes the purchase of substitute service by any active, contributing member of the retirement system  |
| <b>HB 906</b>  | <b>SCHNEIDER</b> | <b>RETIREMENT/DISTRICT ATTY:</b> Provides relative to earnings on Deferred Retirement Option Plan subaccounts   |
| <b>HB 911</b>  | <b>SCHNEIDER</b> | <b>RETIREMENT/CLERKS COURT :</b> Allows repayment of withdrawn accumulated employee contributions by a trustee-to-trustee transfer  |
| <b>HB 912</b>  | <b>SCHNEIDER</b> | <b>RETIREMENT/STATE POLICE :</b> Permits the purchase of service credit for employment with certain law enforcement agencies  |
| <b>HB 914</b>  | <b>SCHNEIDER</b> | <b>RETIREMENT/STATE POLICE :</b> Authorizes the board to grant cost-of-living adjustments under certain circumstances   |
| <b>HB 1279</b> | <b>SCHNEIDER</b> | <b>RETIREMENT/STATE POLICE :</b> Provides with respect to qualification of the system under the provisions of the Internal Revenue Code   |
