HB 711	HAMMETT	<b>LOCAL FINANCE:</b> Authorizes the Louisiana Local Government Environmental Facilities and Community Development Authority to make loans to political subdivisions under certain federal loan guaranty programs		
HB 786	DANIEL	<b>DISTRICTS/TAXING:</b> Provides relative to the Capitol House Taxing District		
HB 809	GUILLORY	<b>PLANNING/ZONING:</b> Increases per diem to be paid to Calcasieu Parish Planning and Zoning Board members and reduces number of meetings for which it may be paid		
HB 833	PEYCHAUD	<b>PROPERTY/ABANDONED:</b> Conforms statutes with constitutional redemptive period provisions affecting post-adjudication donation of abandoned property by parishes and municipalities		
HB 964	LEBLANC	<b>TAX/HOTEL OCCUPANCY:</b> Authorizes the governing authority of Lafayette Parish to increase the tax upon hotel occupancy levied to support the Lafayette Parish Convention and Visitors Commission from 3% to 4%		
HB 1085	ERDEY	<b>DISTRICTS/WATERWORKS:</b> Increases the maximum per diem authorized to be paid to the governing board members of the Ward Two Water District of the Parish of Livingston		
HB 1088	HAMMETT	<b>MUNICIPAL/LAWRASON ACT:</b> Provides for the appointment of the police chief in the town of Clayton		
HB 1127	LANDRIEU	<b>DISTRICTS/NEIGHBORHOOD:</b> Creates the Upper Hurstville Security District in the parish of Orleans		
HB 1165	PEYCHAUD	<b>PROPERTY/ABANDONED:</b> Provides for post-adjudication sale of abandoned property by public or private sale and conforms statutes with constitutional redemptive period provisions affecting such property		
HB 1235	CAZAYOUX	<b>FUNDS/FUNDING:</b> Grants additional taxing authority for certain taxing commissions		
HB 1311	PEYCHAUD	<b>LOCAL GOVERNMENT:</b> Authorizes municipalities and parishes to sell an adjudicated vacant lot by private sale to an adjoining landowner who has maintained the lot for a period of one year		

HB 1432	DANIEL	<b>PROPERTY/PUBLIC:</b> Enacts the Louisiana Purchase Commemorative Act to encourage the acquisition of land by public entities in an effort to set aside green space which can be preserved as our state develops
HB 1459	THOMPSON	<b>HOUSING:</b> Provides for public hearings on proposed housing developments and redevelopment projects
HB 1488	FARRAR	<b>DISTRICTS/WATERWORKS:</b> Authorizes the board of commissioners of waterworks districts to employ a president and to fix his salary
HB 1841	FANNIN	<b>PARKS/STATE:</b> Renames Caney Creek Lake State Park as Jimmy Davis Sunshine State Park
HB 1952	CAZAYOUX	<b>PUBLIC CONTRACTS:</b> Provides for performance based energy efficiency contracts through the RFP process
HCR 114	LAFLEUR	<b>BOARDS/COMMISSIONS:</b> Continues the Louisiana Commission on French and the Louisiana French Study Committee, created in 2001 to assess the condition of the French language in Louisiana
SB 800	BAJOIE	<b>IMMOVABLE PROPERTY:</b> Provides for redemptive period affecting post-adjudication donation of abandoned or blighted property by parishes and municipalities. (gov sig)
SB 830	BAJOIE	<b>IMMOVABLE PROPERTY:</b> Authorizes municipalities and parishes to sell certain adjudicated vacant lots by private sale. (gov sig)
SB 902	BAJOIE	<b>IMMOVABLE PROPERTY:</b> Authorizes municipalities and parishes to sell certain adjudicated vacant lots by public or private sale. (gov sig)
SB 972	BOISSIERE	<b>PARISHES:</b> Provides for the maximum penalties that can be imposed by ordinance in certain parishes for dumping trash and other substances. (gov sig)
