<b>HB 52</b>	<b>G SMITH</b>	<b>EMERGENCY PREPAREDNESS:</b> Prohibits telemarketing activities during declared states of emergency
<b>HB 132</b>	<b>PINAC</b>	<b>FIRE PROTECTION:</b> Provides for the regulation of firestop contracting
<b>HB 312</b>	<b>PINAC</b>	<b>CREDIT/CONSUMER:</b> Exempts nonpublic elementary and secondary schools that finance their tuition from the requirement to file a notice with the commissioner of financial institutions
<b>HB 414</b>	<b>MORRELL</b>	<b>MTR VEHICLE/SALES FIN:</b> Provides penalties for a seller's failure to offer gap insurance
<b>HB 613</b>	<b>FAUCHEUX</b>	<b>ECONOMIC DEVELOPMENT:</b> Creates the Mississippi River Parishes Heritage Area
<b>HB 802</b>	<b>TRICHE</b>	<b>AMUSEMENTS/CARNIVALS:</b> Creates the Louisiana Carnival and Amusement Rider Safety Act
<b>HB 837</b>	<b>PINAC</b>	<b>MTR VEHICLE/DEALERS:</b> Provides for surety bonds for motor vehicle dealers, speciality vehicle dealers, manufacturers, distributors, brokers, satellite warranty and repair centers, and used motor vehicle dealers
<b>HB 1166</b>	<b>J D SMITH</b>	<b>CONSUMERS/FOOD-BEVERAGES:</b> Provides relative to claims on restaurant menus regarding seafood
<b>HB 1328</b>	<b>PINAC</b>	<b>LICENSING:</b> Licenses persons who perform mold assessment and mold remediation services
<b>HB 1795</b>	<b>FUTRELL</b>	<b>COMMERCIAL REGS/ANTITRUS:</b> Limits the capacity of parent entities to conspire with wholly-owned subsidiaries
<b>HB 1889</b>	<b>LUCAS</b>	<b>CREDIT/CONSUMER:</b> Provides relative to certain fees and charges under the Louisiana Consumer Credit Law
<b>HB 1908</b>	<b>MONTGOMERY</b>	<b>MTR VEHICLE/DEALERS:</b> Provides relative to areas of responsibility restrictions for certain marine dealers
<b>HB 1912</b>	<b>SWILLING</b>	<b>CONTRACTORS:</b> Raises the minimum cost threshold for the requirement to obtain a license as a residential building subcontractor
<b>HB 1994</b>	<b>WELCH</b>	<b>SECONDHAND DEALERS:</b> Prohibits a second hand dealer from selling or offering for sale articles of clothing which displays the insignia of a law enforcement agency or public utility company

**LICENSING:**   Requests the House Committee on Commerce to study the possibility of licensing persons who install landscape irrigation systems

**HR 42      MONTGOMERY**

**RACING/COMMISSION:**   Allows Louisiana State Racing Commission additional time to study the potential ramifications of licensing any additional racing facilities in Louisiana
