Remarks:

<b>HB 691</b>	<b>FARRAR</b>	<b>INSURERS/ALIEN:</b> Increases the deposit and bond required of foreign and alien insurers
<b>HB 1420</b>	<b>HEBERT</b>	<b>INSURANCE/RATES:</b> Limits the number of times a rate increase can be approved by the Louisiana Insurance Rating Commission to one in a twelve month period
<b>HB 1439</b>	<b>HEBERT</b>	<b>INSURANCE/HEALTH:</b> Provides relative to certain limitations placed on premium rates for small groups and individuals
<b>HB 1440</b>	<b>HEBERT</b>	<b>INSURANCE/HEALTH:</b> Clarifies various provisions relative to employer group trusts, multiple employer trusts, association health coverage, and health maintenance organizations
<b>HB 1666</b>	<b>LAFLEUR</b>	<b>INSURANCE CLAIMS:</b> Provides for damages for the breach of a good faith duty to settle an insurance claim
<b>HB 1784</b>	<b>TOWNSEND</b>	<b>INSURANCE/LIABILITY:</b> Requires written notice by liability insurers to a payee-obligee of payment of claims in third-party settlements
<b>HB 1995</b>	<b>HEBERT</b>	<b>INSURANCE COMMISSIONER:</b> Repeals the use of directives by the commissioner of insurance
<b>SB 55</b>	<b>C FIELDS</b>	<b>AUTOMOBILE INSURANCE:</b> Prohibits insurers from canceling an automobile insurance policy under certain circumstances.
<b>SB 56</b>	<b>C FIELDS</b>	<b>INSURERS:</b> Prohibits certain uses of credit information in establishing rates for personal insurance.
<b>SB 245</b>	<b>HAINKEL</b>	<b>INSURANCE DEPARTMENT:</b> Limits the authority of the Louisiana Insurance Rating Commission. (1/1/04)
<b>SB 408</b>	<b>GAUTREAUX</b>	<b>INSURANCE MANDATES:</b> Provides for health insurance coverage for hearing aids for minor children
<b>SB 567</b>	<b>LENTINI</b>	<b>INSURANCE POLICIES:</b> Prohibits the surrender of a defendant for nonpayment of bail bond premium. (gov sig)
<b>SB 601</b>	<b>LENTINI</b>	<b>INSURERS:</b> Provides for certain licensing requirements for the solicitation of bail; provides for certain prohibited activities. (gov sig)
<b>SB 721</b>	<b>HAINKEL</b>	<b>INSURANCE RATES:</b> Creates a flexible rating process for property and casualty insurance rates.
