<b>HB 989</b>	<b>TOWNSEND</b>	<b>HEALTH CARE/PROVIDERS:</b> Provides relative to health care services
<b>HB 1922</b>	<b>LANDRIEU</b>	<b>COURTS:</b> Requires review and recommendation of juvenile justice reform by the Judicial Council
<b>HB 1933</b>	<b>DEVILLIER</b>	<b>HOSPITALS:</b> Requires patient transfers in accordance with DHH rules and regulations
<b>HB 1960</b>	<b>PERKINS</b>	<b>COUNSELORS:</b> Provides for the Employee Assistance Professional Certification Act
<b>SB 116</b>	<b>DARDENNE</b>	<b>AGED PERSONS:</b> Requires DSS to promulgate rules to require adult residential care homes to provide for residents during times of emergency and natural disasters.
<b>SB 294</b>	<b>DARDENNE</b>	<b>DENTISTRY:</b> Revises the practice of dentistry. (2/3-CA7s2.1)
<b>SB 296</b>	<b>DARDENNE</b>	<b>DENTISTRY:</b> Revises the dental practice act relative to judicial review of adjudication.
<b>SB 297</b>	<b>DARDENNE</b>	<b>DENTISTRY:</b> Revises the practice of dentistry to provide relative to the unlicensed practice of dentistry and dental hygiene.
<b>SB 309</b>	<b>SCHEDLER</b>	<b>VITAL STATISTICS:</b> Revises period of time within which to provide missing information on a birth certificate.
<b>SB 315</b>	<b>SCHEDLER</b>	<b>FEES/LICENSES/PERMITS:</b> Creates the Perfusion Licensure Act to provide for the licensing of medical technicians to practice perfusion. (7/1/03)
<b>SB 378</b>	<b>SCHEDLER</b>	<b>HEALTH/HOSPITALS DEPT:</b> Provides for mandatory accreditation by either Joint Commission on the Accreditation of Health Care Organizations or council on the Accreditation of Rehabilitation Facilities.
<b>SB 388</b>	<b>SCHEDLER</b>	<b>HEALTH/HOSPITALS DEPT:</b> Prevents the Department of Health and Hospitals from limiting the availability of prescription drugs to treat HIV/AIDS, hepatitis C, and atypical antipsychotic drugs to Medicaid recipients.
<b>SB 430</b>	<b>SCHEDLER</b>	<b>HEALTH CARE:</b> Requires disclosure of financial, employment, or economic interest in hospital physical therapy services by certain referring health care providers.
<b>SB 500</b>	<b>SCHEDLER</b>	<b>HEALTH/HOSPITALS DEPT:</b> Extends moratoria on mental health clinics and centers, long-term care hospital facilities, nursing facilities, and home health agencies through July 1, 2008 and adds to and places a moratorium on designation of rural hospitals. (gov sig)
