| HCR 149 | ANSARDI | CIVIL/JURIES: Requests the Judicial Council of the Louisiana Supreme Court to study funding sources for compensation to jurors who serve on lengthy trials |
| HCR 157 | ANSARDI | CIVIL/JURIES: Requests the Judicial Council of the Louisiana Supreme Court to study the implementation of a one day, one trial system for petit juries |
| HB 264 | BALDONE | COURTS/CITY: Authorizes the destruction of certain records in the City Court of Houma |
| HB 1123 | HOPKINS | PARISH/POLICE JURIES: Authorizes governing authority or sheriff of Caddo Parish to charge prisoners for the expenses of incarceration |
| HB 1319 | MURRAY | BONDS/BAIL: Authorizes all criminal district courts to alter the percentage amount of bail and to charge a fee for processing bail bond |
| HB 1902 | PERKINS | MILITARY AFFAIRS: Requires the office of homeland security and emergency preparedness to establish a medical distribution system for the distribution of antibiotics |
| HB 1916 | DARTEZ | POLICE/LOCAL: Provides for disposition of noncontraband property by local police departments |
| HB 1937 | GLOVER | POLICE/MUNICIPAL: Requires all peace officers employed by certain municipalities to complete a specified training course annually and provides for certain penalties for failure to do so |
| SCR 21 | MICHOT | COMMITTEE STUDIES: Creates special committee to develop recommendations for standards of records management technologies for clerks of court's offices. |
| SB 26 | THEUNISSEN | VETERANS: Provides for membership on the Louisiana Veterans Affairs Commission. (gov sig) |
| SB 76 | ELLINGTON | SHERIFFS: Requires that the insurance premiums of the sheriff and certain deputy sheriffs of LaSalle Parish shall be paid in full from the sheriff's general fund. |
| SB 457 | DUPRE | CIVIL PROCEDURE: Authorizes justice of the peace court to have jurisdiction over the removal, disposition or abandonment of certain objects. |
| SB 752 | LENTINI | CRIMINAL PROCEDURE: Authorizes the court in Jefferson Parish to alter the percentage amount of bail to be deposited when posting a bond and to charge an administrative fee. |

SB 773 BOISSIERE

LIABILITY INSURANCE: Provides that a reasonable fee, not to exceed \$20.00, may be charged for accident reports in a parish with a population in excess of 475,000.

SB 849 ELLINGTON

LAW ENFORCEMENT: Establishes the Law Enforcement Executive Management Institute. (gov sig)

SB 1016 DUPRE

COURTS: Provides for an increase in court fees for the City Court of Houma and the Terrebonne Parish Consolidated Government.

SB 1098 DARDENNE

COURTS: Authorizes the Nineteenth Judicial District Court to designate matters to be heard by specific divisions of the court.
