<b>HR 18</b>	<b>FARRAR</b>	<b>INSURANCE/RATING COMM:</b> Requests that the Insurance Rating Commission report to the House Insurance Committee on the impact of the flexible rating process prior to the 2005 Regular Session
<b>HB 269</b>	<b>ERDEY</b>	<b>INSURANCE/HEALTH:</b> Provides relative to the Louisiana Health Plan
<b>HB 315</b>	<b>FARRAR</b>	<b>INSURERS/GUARANTY ASSNS:</b> Authorizes an increase in the assessment of its member insurers by the Louisiana Insurance Guaranty Association
<b>HB 398</b>	<b>JOHNS</b>	<b>INSURANCE/POLICIES:</b> Defines "delivered" for purposes of notice of cancellation
<b>HB 423</b>	<b>MORRISH</b>	<b>INSURANCE/PROPERTY:</b> Provides for the dates for the fiscal year and reporting requirements for the FAIR and Coastal plans
<b>HB 517</b>	<b>JOHNS</b>	<b>INSURANCE/PROPERTY:</b> Provides for governance and administration of Louisiana Insurance Underwriting Plan (Coastal Plan) and Louisiana Joint Reinsurance Plan (Fair Plan)
<b>HB 584</b>	<b>TOOMY</b>	<b>INSURANCE:</b> Prohibits third-party administrators from selling insurance products or accepting commissions
<b>HB 643</b>	<b>HEBERT</b>	<b>INSURANCE/LIFE:</b> Exempts credit life insurance from inclusion in the central database
<b>HB 711</b>	<b>BROOME</b>	<b>SOCIAL WORKER:</b> Provides relative to payable benefits and reimbursement for certain services provided by a social worker
<b>HB 734</b>	<b>WALKER</b>	<b>INSURERS:</b> Prohibits failure to use positive claims history for writing commercial liability insurance
<b>HB 752</b>	<b>MORRISH</b>	<b>INSURANCE/PROPERTY:</b> Deletes farmowners' multiperil insurance from the La. Citizens Property Insurance Corporation
<b>HB 996</b>	<b>FAUCHEUX</b>	<b>INSURANCE:</b> Prohibits third party administrators from selling insurance products or accepting commissions
<b>HB 1051</b>	<b>FARRAR</b>	<b>INSURERS/GUARANTY ASSNS:</b> Provides for procedures for asserting claims against LIGA involving asbestos exposure
<b>HB 1052</b>	<b>FARRAR</b>	<b>INSURERS/GUARANTY ASSNS:</b> Provides for determining net worth for purpose of covered claims under LIGA

**INSURANCE/HEALTH:**    Provides    relative to premiums charged for individual health insurance coverage

**HB 1079    K CARTER**

**INSURERS/GUARANTY ASSNS:**    Excludes state agencies as self-insureds under LIGA

**HB 1424    BOWLER**

**INSURERS/GUARANTY ASSNS:**    Repeals law requiring LIGA to deposit monies into the state general fund
