| <b>HB 13</b>   | <b>BALDONE</b>  | <b>CONSTITUTION/CONVENTION :</b> Provides for a general constitutional convention to be convened in August, 2004   |
| <b>HB 73</b>   | <b>PITRE</b>    | <b>CONSTITUTION/AMENDMENT:</b> (Constitutional Amendment) Specifies that the law providing for the calling of a constitutional convention may limit the matters to be considered by the constitutional convention  |
| <b>HB 123</b>  | <b>PITRE</b>    | <b>CONSTITUTION/CONVENTION :</b> Provides for a constitutional convention to be convened in January, 2005  |
| <b>HB 421</b>  | <b>BEARD</b>    | <b>PUBLIC RECORDS:</b> Provides that the laws relative to public records are not applicable to certain proprietary or trade secret information   |
| <b>HB 48</b>   | <b>CROWE</b>    | <b>LEGISLATIVE SESSIONS:</b> (Constitutional Amendment) Prohibits consideration or enactment of a new state fee or an increase in an existing state fee during regular sessions in even-numbered years except with prior three-fourths legislative approval under certain circ |
| <b>HB 544</b>  | <b>BRUNEAU</b>  | <b>LEGISLATIVE AFFAIRS:</b> Relative to legislators-elect, provides for reimbursement for orientation, allows for certain actions and expenditures relative to the establishment of district offices, and allows hiring of legislative assistants                              |
| <b>HB 787</b>  | <b>HUNTER</b>   | <b>LEGISLATIVE AFFAIRS:</b> Allows meetings of legislative committees held in the interim between session to be conducted by video conference  |
| <b>HB 1297</b> | <b>TOWNSEND</b> | <b>LEGISLATION:</b> Provides with respect to the interpretation of laws  |
| <b>HB 1375</b> | <b>ALARIO</b>   | <b>LEGISLATIVE COMM/BUDGET :</b> Provides for salary of chairmen and vice chairmen of legislative committees   |
| <b>HB 1442</b> | <b>HUNTER</b>   | <b>ELECTED OFFICIALS:</b> Provides for the salary of members of the legislature  |
| <b>HB 1443</b> | <b>SALTER</b>   | <b>ELECTED OFFICIALS:</b> Provides for the salaries of the statewide elected officials   |
