| <b>HR 5</b>    | <b>HAMMETT</b>  | <b>REVENUE DEPARTMENT:</b> Request the Department of Revenue to study the Internal Revenue Service's and other states' taxpayer advocacy programs   |
| <b>HB 198</b>  | <b>BRUNEAU</b>  | <b>TAX/GIFT TAX:</b> Phases in a reduction and then repeal of the gift tax  |
| <b>HB 485</b>  | <b>BRUNEAU</b>  | <b>TAX/AD VALOREM-EXEMPTION:</b> Authorizes exemption of motor vehicles, owned by persons sixty-five years of age or older, from general or special ad valorem taxes of municipalities or districts created by them |
| <b>HB 500</b>  | <b>HAMMETT</b>  | <b>TAX RETURN:</b> Authorizes secretary of Department of Revenue to require electronic returns by rule  |
| <b>HB 777</b>  | <b>HAMMETT</b>  | <b>TAX/TAXATION:</b> (Constitutional Amendment) Adds gasoline, diesel fuels, and other special fuels to items which local political subdivisions are prohibited from taxing   |
| <b>HB 778</b>  | <b>TOWNSEND</b> | <b>TAX/TAXATION:</b> (Constitutional Amendment) Adds gasoline, diesel fuels, and other special fuels to items which local political subdivisions are prohibited from taxing   |
| <b>HB 880</b>  | <b>HAMMETT</b>  | <b>TAX/TAXATION:</b> Authorizes arbitration and mediation of tax issues and removes limitation of one million dollars or less   |
| <b>HB 1108</b> | <b>ERDEY</b>    | <b>ASSESSORS:</b> Authorizes the utilization of alternative population data as a basis for determining compensation   |
| <b>HB 1303</b> | <b>HAMMETT</b>  | <b>TAX RETURN:</b> Provides that the interest rate on refunds begin to accrue 90 days from date of return or date filed   |
| <b>HB 1390</b> | <b>HUTTER</b>   | <b>TAX/SALES &amp; USE:</b> Provides for a donation for certain public institutions of higher education   |
| <b>HB 1419</b> | <b>HAMMETT</b>  | <b>FEES/LICENSES/PERMITS:</b> Authorizes Louisiana Tax Commission to assess fees for its services through June 30, 2006   |
| <b>HB 1472</b> | <b>MURRAY</b>   | <b>ASSESSORS:</b> Requires taxpayers who own property in Orleans Parish to notify the assessors of change   |
