- HB 59 BRUCE (TBA) LIBRARIES:** Transfers the administration and accounting of funds of the DeSoto Parish Library from the DeSoto Parish Police Jury to the DeSoto Parish Library Board of Control (**Subject to Rule Suspension**)
- HB 174 FANNIN TAX/SALES-USE, LOCAL:** Authorizes the parish of Jackson to levy and collect an additional sales and use tax
- HB 176 KENNEY TAX/SALES-USE, LOCAL:** Authorizes the village of Baskin to levy and collect an additional sales and use tax
- HB 193 SALTER PROCUREMENT:** Provides with respect to the public notice of the request for proposals for procurement of certain used fire and emergency response vehicles and equipment by local political subdivisions
- HB 212 BOWLER CIVIL SERVICE/FIRE & POL:** Authorizes the fire and police civil service board in small municipalities, parishes, and fire protection districts to award attorney fees to appealing employee under certain circumstances
- HB 260 FLAVIN OFFICIAL JOURNALS:** Provides that copies of the official proceedings of any local governing body must be furnished to the official journal within ten days of any meeting or within ten days from the date the minutes of the meeting were approved
- HB 271 ST GERMAIN DISTRICTS/SPECIAL:** Increases the maximum rate of ad valorem tax which the Iberville Parks and Recreation District is authorized to levy
- HB 543 ARNOLD LOCAL GOVERNMENT:** (Constitutional Amendment) Authorizes the legislature to provide, by local law, for the incorporation of the fifteenth ward of the parish of Orleans and to change the boundaries of the city of New Orleans
- HB 610 DANIEL (TBA) WATER/SEWER OPERATORS:** Requires that agreements between sewerage service entities and water service entities provide for shutting off of water to enforce collection of sewer charges (**Subject to Rule Suspension**)
- HB 756 KENNEY LIBRARIES:** Transfers the administration and accounting of funds of the Caldwell Parish Library from the Caldwell Parish Police Jury to the Caldwell Parish Library Board of Control
- HB 916 CAZAYOUX FIRE PROTECT/FIREMEN:** Provides relative to the rights of fire employees
- HB 933 FANNIN TAX/SEVERANCE TAX:** Use of timber severance tax proceeds by local governing authorities

HB 952	FRITH (TBA)	DISTRICTS/HOSPITAL SERVC: Increases the maximum per diem authorized to be paid to members of the board of commissioners of Hospital Service District No. 1 of the parish of Vermilion (Subject to Rule Suspension)
HB 953	McVEA (TBA)	DISTRICTS/SPECIAL: Relative to the board of commissioners of Gas Utility District No. 1 of West Feliciana Parish, increases membership and provides for terms (Subject to Rule Suspension)
HB 962	E GUILLORY	DISTRICTS/ECONOMIC DEVEL: Authorizes certain changes relative to the North Lake Charles Economic Development District
HB 967	FLAVIN	DISTRICTS/TAXING: Authorizes the governing authority of the city of Lake Charles to create a special taxing district
HB 968	FANNIN	MUSEUMS: Authorizes the governing authority of the parish of Jackson to create a museum board
HB 974	ARNOLD	PARKS: Creates the Algiers Park Commission within the parish of Orleans
HB 1096	TOOMY	FIRE PROTECT/FIREMEN: Includes certain firefighting activities within scope of official duties
HB 1134	M JACKSON	TAX/TAXATION: Provides for tax increment financing within the parish of East Baton Rouge
HB 1160	ALARIO (TBA)	CIVIL SERVICE/FIRE & POL: Provides for the position of assistant police chief in certain municipalities (Subject to Rule Suspension)
HB 1184	CAZAYOUX	CIVIL SERVICE/FIRE & POL: Provides for the length of time within which municipal fire and police civil service boards shall conduct certain investigations
HB 1189	ARNOLD	LOCAL GOVERNMENT: Provides for the incorporation of the fifteenth ward of the parish of Orleans as a municipality within the parish of Orleans
HB 1329	THOMPSON	RAILROADS: Authorizes the creation of a railroad development district
HB 1501	ALARIO (TBA)	PUBLIC BUILDINGS/GROUNDS: Authorizes certain parish governing authorities to name an administrative building in honor of a former parish president under certain circumstances (Subject to Rule Suspension)
HB 1512	ALARIO (TBA)	PUBLIC BUILDINGS/GROUNDS: Authorizes certain parish governing authorities to name an entryway or entry plaza to parish administrative buildings in honor of a former parish councilman under certain circumstances (Subject to Rule Suspension)
HB 1642	DAMICO (TBA)	TAX/HOTEL OCCUPANCY: Relative to hotel occupancy tax in Jefferson Parish (Subject to Rule Suspension)
HCR 99	HUTTER (TBA)	LOCAL EMPLOYEES: Requests the New Orleans City Council to review and consider amending city domicile requirements relative to employees of the Louis Armstrong International Airport (Subject to Rule Suspension)
