HB 376	GLOVER	ECONOMIC DEVELOPMENT: Creates the Louisiana Historically Underutilized Business Program
HB 829	BEARD	BUDGETARY CONTROLS: (Constitutional Amendment) Mandates full funding of salaries paid to members of the state police service
HB 1291	ERDEY	PUBLIC BUILDINGS/GROUNDS: Authorizes contracts with a private entity to paint the flag of the United States and "God Bless America" on the roof of the Louisiana Superdome
HB 1381	DORSEY	APPROPRIATIONS/SUPP PAY : Provides state supplemental pay to deputy sheriffs who perform civil process services for East Baton Rouge Parish
HB 1503	SCALISE	STUDENT/LOANS-SCHOLARSHIP: Provides, effective for initial TOPS awards for the 04-05 award year, relative to minimum scores on specified standardized tests that are required of certain home study students
HB 1629	GLOVER	PROCUREMENT: Prohibits the state and political subdivisions from entering into certain social services contracts
HB 1645	SCALISE	CONTRACTS: Prohibits the approval of state contracts under certain circumstances
HB 1711	WOOTON	FISHING/SHRIMP: Provides for additional fees for those involved in the shrimp industry and dedicates those revenues
SB 12	THEUNISSEN	ROADS/HIGHWAYS: Extends the authorization for appropriation of state funds for the Monkey Island Ferry until July 1, 2008.
SB 41	MCPHERSON	FISCAL CONTROLS: Provides for settlement of certain claims by the state.
SB 72	MCPHERSON	SUITS AGAINST STATE: Requires written notification to the Budget Committee of any pending claims against the state that may equal or exceed \$2,500,000.
SB 288	SCHEDLER	FUNDS/FUNDING: Provides for the distribution of certain funds by the St. Tammany Parish Tourist and Convention Commission. (gov sig)

SB 363	HOLDEN	SCHOOLS: Provides for the state to discharge certain debts owed the state by the city of Baker School Board. (6/30/04)
SB 463	DARDENNE	FUNDS/FUNDING: Provides for the investment of certain monies in the Louisiana Education Quality Trust Fund. (7/1/04)
SB 468	FONTENOT	HAZARDOUS WASTE: Establishes the Brownfields Cleanup Revolving Loan Fund.
SB 493	SCHEDLER	FUNDS/FUNDING: Abolishes the Medicaid School-Based Administrative Claiming Trust Fund and provides for direct reimbursement of monies to public schools. (7/1/04)
SB 560	FONTENOT	ENVIRONMENTAL QUALITY: Provides relative to the Motor Fuels Underground Storage Tank Trust Fund. (gov sig)
SB 654	BAJOIE	TANF: Provides for eligibility for FITAP benefits, and removes restriction on earned income disregard for TANF.
SB 749	CAIN	FUNDS/FUNDING: Provides for the distribution of the proceeds of all of the state sales tax on hotel/motel rooms in Vernon Parish. (7/1/04)
SB 769	HEITMEIER	PUBLIC EMPLOYEES: Provides for payroll deductions for certain foreign corporations. (gov sig)
SB 785	C D JONES	SCHOOLS: Provides for the creation of the Northeast Louisiana Delta Learning Center.
SB 811	M SMITH	TRANSPORTATION/DEV DEPT : Provides for contract and procurement by agencies in the department. (5/1/04)
SB 842	C ROMERO	WATER/WATERWAYS: Provides relative to the Acadiana Gulf of Mexico Access Channel.
SCR 139	L JACKSON	COMMITTEE STUDIES: Directs the Joint Legislative Committee on the Budget to create a task force to study practices and standards of departments and agencies in the executive branch of state government in contracting with nonprofit organizations.
