| <b>HB 860</b>  | <b>SCHNEIDER</b>  | <b>RETIREMENT/STATE-STWIDE :</b> Provides for the determination of employer contributions for state retirement systems  |
| <b>HB 1152</b> | <b>SCHNEIDER</b>  | <b>RETIREMENT/STATE-STWIDE :</b> Authorizes certain retirement systems to invest 65% of their total portfolios in equities  |
| <b>SB 82</b>   | <b>BOISSIERE</b>  | <b>LOCAL RETIREMENT:</b> Changes the interest paid on Deferred Retirement Option Plan for members of the New Orleans Firefighters' Pension and Relief Fund who continue employment after participation in the plan ceases. (gov sig)                    |
| <b>SB 90</b>   | <b>BOISSIERE</b>  | <b>LOCAL RETIREMENT:</b> Authorizes the New Orleans Firefighters Association, Local 632 and the Firefighters' Pension and Relief Fund for the city of New Orleans to negotiate a cooperative endeavor agreement with the city of New Orleans. (gov sig) |
| <b>SB 352</b>  | <b>BOISSIERE</b>  | <b>STATE EMPLOYEE RET:</b> Provides with respect to employment of retired members. (gov sig)  |
| <b>SB 622</b>  | <b>BOISSIERE</b>  | <b>STATE EMPLOYEE RET:</b> Relative to the experience account of the Louisiana State Employee's Retirement System. (6/30/04)  |
| <b>SB 623</b>  | <b>BOISSIERE</b>  | <b>TEACHERS RETIREMENT:</b> Relative to the experience account of the Teachers' Retirement System of Louisiana. (6/30/04)   |
| <b>SB 696</b>  | <b>DARDENNE</b>   | <b>RETIREMENT SYSTEMS:</b> Exands seizure for child support to include retirement benefit, refund of accumulated contributions or a portion thereof. (gov sig)  |
| <b>SB 790</b>  | <b>THEUNISSEN</b> | <b>STATE EMPLOYEE RET:</b> Changes the anti-spiking provisions of LASERS. (gov sig)   |
| <b>SB 792</b>  | <b>DARDENNE</b>   | <b>STATE EMPLOYEE RET:</b> Changes the retirement for new members of LASERS. (gov sig)  |
| <b>SCR 12</b>  | <b>DARDENNE</b>   | <b>RETIREMENT SYSTEMS:</b> Requires the four state public retirement systems to comply with state policies, procedures and regulations governing travel, contracts and procurement.   |
| <b>SCR 15</b>  | <b>DARDENNE</b>   | <b>RETIREMENT SYSTEMS:</b> Provides for a study of the benefits, risks, and issues involved in, and the feasibility of establishing, a defined contribution plan in all four state public retirement systems.   |
