Remarks:

<b>HB 345</b>	<b>HEBERT</b>	<b>INSURANCE/LIFE:</b> Changes the termination date for the interest rate paid on annuities
<b>HB 349</b>	<b>HEBERT</b>	<b>INSURANCE/HOMEOWNERS:</b> Requires actual payment by the insurer for there to be a claim against a homeowner's policy
<b>HB 399</b>	<b>JOHNS</b>	<b>INSURANCE/HEALTH:</b> Revises certain provisions relative to medical necessity review organizations
<b>HB 523</b>	<b>HEBERT</b>	<b>INSURERS/AGENTS:</b> Provides relative to prelicensing and continuing education requirements for insurance agents
<b>HB 679</b>	<b>HEBERT (TBA)</b>	<b>INSURANCE CLAIMS-ADJUSTR:</b> Provides for licensing and regulation of public insurance adjusters <b>(Subject to Rules Suspension)</b>
<b>HB 712</b>	<b>MURRAY</b>	<b>INSURANCE:</b> Requires affidavit showing liability insurance information to be delivered to claimant
<b>HB 755</b>	<b>TUCKER</b>	<b>INSURANCE/AUTOMOBILE:</b> Require insurers to use the rates of the home state of active military personnel for their automobile liability insurance
<b>HB 761</b>	<b>HEBERT</b>	<b>INSURERS/AGENTS:</b> Provides relative to licensure of insurance producers
<b>HB 797</b>	<b>TUCKER</b>	<b>INSURANCE/AUTOMOBILE:</b> Provides for a discount for automobile liability insurance for active military personnel paid by a credit on the premium taxes
<b>HB 923</b>	<b>HEBERT</b>	<b>INSURANCE/HEALTH:</b> Provides relative to medical necessity reviews, benefit determinations, grievance procedures, and external reviews
<b>HB 996</b>	<b>FAUCHEUX</b>	<b>INSURANCE:</b> Prohibits third party administrators from selling insurance products or accepting commissions
<b>HB 1053</b>	<b>HEBERT</b>	<b>INSURERS:</b> Authorizes domestic insurers to place their securities with a brokerage firm
<b>HB 1142</b>	<b>TOWNSEND</b>	<b>INSURANCE/LIABILITY:</b> Requires written notice by liability insurers to a payee-obligee of payment of claims in third-party settlements
<b>HB 1361</b>	<b>JOHNS</b>	<b>INSURANCE:</b> Provides for the sale of insurance products by financial institutions
