| HB 515 | MONTGOMERY | MUNICIPAL/LAWRASON ACT: Provides for the appointment of the police chief in certain municipalities |
| HB 1296 | GLOVER | DISTRICTS/SPECIAL: Creates and provides for a taxing district in the City of Shreveport |
| HB 1587 | BADON | PUBLIC HEALTH: Provides that parish and municipal governing authorities may establish air quality standards in restaurants |
| HB 1635 | GLOVER | POLICE/MUNICIPAL: Authorizes the city of Shreveport to create a citizens review board to review actions of police officers |
| HB 1647 | FAUCHEUX | MUSEUMS: Provides with respect to the transfer of ownership of the building known as the St. John the Baptist Parish theater to the Garyville Timbermill Museum |
| HB 1656 | WRIGHT | DISTRICTS/WATERWORKS: Exempts waterworks districts from the requirement to hire an engineer for certain projects |
| HB 1669 | BROOME | CULTURE/REC/TOUR: Establishes the Neighborhood Enhancement Program within the Department of Culture, Recreation and Tourism |
| HB 1682 | HONEY | CORPORATIONS: Provides for quasi-public nonprofit corporation |
| HB 1684 | G SMITH | PROPERTY/SUBSTANDARD: Authorizes St. Charles Parish to acquire abandoned or blighted property under certain circumstances |
| SB 133 | C FIELDS | SPECIAL DISTRICTS: Creates the Concord Estates Crime Prevention District. |
| SB 218 | C FIELDS | SPECIAL DISTRICTS: Creates the South Burbank Crime Prevention and Development District. (gov sig) |
| SB 356 | CHEEK | MUNICIPALITIES: Provides for renewal of certain additional sales and use taxes in the city of Shreveport. |
| SB 483 | ULLO | MUSEUMS: Provides relative to the Jean Lafitte Marine Fisheries Museum. |
| SB 756 | C D JONES | SPECIAL DISTRICTS: Authorizes per diem for the Madison Parish Hospital Service District Board of Commissioners. (gov sig) |
| SB 757 | C D JONES | EXPROPRIATION: Authorizes the city of Monroe to take possession of adjudicated property. (gov sig) |

SB 758 C D JONES

TAX/LOCAL: Authorizes the city of Monroe to levy and collect an additional sales and use tax. (gov sig)

SB 794 MICHOT

LOCAL FINANCE: Authorizes municipalities, with voter approval, to levy and collect additional sales and use taxes. (gov sig)

SB 801 C ROMERO

LOCAL FINANCE: Authorizes political subdivisions, with voter approval, to renew or continue any sales tax for any purpose set forth in the proposition and provides that renewal or continuation may exceed constitutional or statutory limit on tax rates. (gov sig)
