- HCR 134 LAFONTA (TBA)** **REVENUE DEPARTMENT** Directs the Department of Revenue to accept amended income tax returns for 2002, 2003, and 2004 and make refunds to reflect the appropriate amount of exemption for retirement income of certain persons sixty-five years or older **(Subject to Rule Suspension)**
- HB 97 STRAIN (TBA)** **TAX/GASOLINE-EXEMPT** Provides for reimbursement of the tax on gasoline and special fuels for privately owned school buses **(Subject to Rule Suspension)**
- HB 394 KENNEY (TBA)** **TAX/INCOME TAX** Provides a deduction to school teachers for school supply purchases **(Subject to Rule Suspension)**
- HB 410 FARRAR (TBA)** **TAX/SALES-USE, ST-EXEMPT** Excludes sales or purchases by churches from the state sales and use tax **(Subject to Rule Suspension)**
- HB 420 MARCHAND (TBA)** **TAX/INCOME-CREDIT** Establishes an income tax credit for the rehabilitation of residential structures in certain areas **(Subject to Rule Suspension)**
- HB 500 CARTER, K. (TBA)** **TAX/TAXATION** Provides with respect to tax credits for certain biotechnology companies **(Subject to Rule Suspension)**
- HB 602 DANIEL (TBA)** **TAX/TAXATION** Extends tax credit for the rehabilitation of historic structures located in a downtown development district **(Subject to Rule Suspension)**
- HB 631 CARTER, K. (TBA)** **TAX CREDITS** Authorizes sound recording investor tax credits **(Subject to Rule Suspension)**
- HB 634 HEBERT (TBA)** **TAX/FUELS, SPECIAL** Increases the special fuels tax refund for contract school bus drivers **(Subject to Rule Suspension)**
- HB 747 HAMMETT (TBA)** **TAX/SALES & USE** Establishes sales price of refinery gas sold to another person **(Subject to Rule Suspension)**
- HB 765 GLOVER (TBA)** **TAX CREDITS** Provides for certain tax credits available to employers for new jobs created in the state **(Subject to Rule Suspension)**
- HB 807 HAMMETT (TBA)** **TAX/TAXATION** Authorizes imposition or increase in certain fees and taxes by the Louisiana Stadium and Exposition District **(Subject to Rule Suspension)**
- HB 808 HAMMETT (TBA)** **DISTRICTS/STADIUM** Authorizes Louisiana Stadium and Exposition District to levy an automobile rental fee **(Subject to Rule Suspension)**

HB 809	HAMMETT (TBA)	DISTRICTS/STADIUM Authorizes the Louisiana Stadium and Exposition District to increase certain taxes and to impose certain taxes and fees (Subject to Rule Suspension)
HB 811	MORRISH (TBA)	TAX/SALES-USE, STATE Provides for a state sales and use tax limitation on the sales price and cost price of natural gas and to phase in the restoration of the sales tax exemption for natural gas (Subject to Rule Suspension)
HB 818	JACKSON, M. (TBA)	TAX/CORP INCOME Provides for a deduction for interest, dividends, and profits from incorporeals (Subject to Rule Suspension)
HB 828	HEATON (TBA)	TAX CREDITS Provides for the promotion of the music recording industry by providing for certain music tax credits (Subject to Rule Suspension)
HB 850	CROWE (TBA)	TAX/SALES-USE, STATE Provides an exclusion for certain hovercrafts used in mineral production (Subject to Rule Suspension)
HB 871	MARCHAND (TBA)	TAX/TAXATION Authorizes the child care tax credit without regard as to whether the federal credit is claimed (Subject to Rule Suspension)
