| <b>HB 224</b> | <b>DARTEZ</b>        | <b>FUNDS/FUNDING</b> Increases the balance in the Dept. of Justice Legal Support Fund dedicated to support the Department of Justice   |
| <b>HB 393</b> | <b>BRUNEAU</b>       | <b>GAMING/REVENUE</b> Increases the amount of monies dedicated for deposit into the Beautification and Improvement of the New Orleans City Park Fund from the Pari-mutuel Live Racing Facility Gaming Control Fund             |
| <b>HB 623</b> | <b>LAFLEUR (TBA)</b> | <b>FUNDS/FUNDING</b> Provides for the distribution of revenues deposited in the St. Landry Parish Excellence Fund <b>(SUBJECT TO RULES SUSPENSION)</b>   |
| <b>HB 654</b> | <b>MONTGOMERY</b>    | <b>BONDS</b> Authorizes securitization of unclaimed property revenues to provide funds for I-49 North and South projects   |
| <b>HB 714</b> | <b>LAMBERT (TBA)</b> | <b>FUNDS/FUNDING</b> Relative to the dedication of revenues, provides for the allowable uses of monies in the Ascension Parish Visitor Enterprise Fund <b>(SUBJECT TO RULES SUSPENSION)</b>                                    |
