| <b>HB 8</b>   | <b>RITCHIE</b>      | <b>COURTS/CITY</b> Increases the civil jurisdictional amount of the City Court of Bogalusa  |
| <b>HB 18</b>  | <b>SMITH, JOHN</b>  | <b>COURTS/COURT REPORTERS</b> Provides for court reporter fees in the 36 <sup>th</sup> JDC  |
| <b>HB 32</b>  | <b>ANSARDI</b>      | <b>CHILDRENS CODE</b> Authorizes hearing officers to accept mediation agreements  |
| <b>HB 44</b>  | <b>MORRELL</b>      | <b>SHERIFFS</b> Increases the fees charged for issuance of a notice of seizure on specific property   |
| <b>HB 82</b>  | <b>MORRELL</b>      | <b>FEES/LICENSES/PERMITS</b> Increases the fee on premiums for commercial surety underwriters who write criminal bail bonds   |
| <b>HB 95</b>  | <b>SMITH, GARY</b>  | <b>MILITARY AFFAIRS/NATL GD</b> Provides for reimbursement of members of LANG for premiums paid for life insurance  |
| <b>HB 134</b> | <b>CROWE</b>        | <b>COURTS/CITY</b> Provides for the transfer of surplus funds or unclaimed fees for the City Court of Slidell   |
| <b>HB 151</b> | <b>DOVE</b>         | <b>COURTS/COURT REPORTERS</b> Increase fees for court reporters in the 32 <sup>nd</sup> JDC   |
| <b>HB 161</b> | <b>BRUCE</b>        | <b>COURTS</b> Provides for court reporter fees in the Eleventh Judicial District Court  |
| <b>HB 166</b> | <b>MCDONALD</b>     | <b>COURTS/JUSTICE OF PEACE</b> Provides that the election districts for the justice of the peace courts in West Carroll Parish shall coincide with parish police jury districts                           |
| <b>HB 172</b> | <b>ROMERO, E.</b>   | <b>COURTS/JUSTICE OF PEACE</b> Increases the jurisdictional amount in dispute in civil matters, matters concerning ownership or possession of movable property, and in certain eviction proceedings       |

<b>HB 194</b>	<b>FAUCHEUX</b>	<b>TAX/LOCAL</b> Authorizes sheriff to retain attorney for tax and fee collection with taxing bodies paying attorney fees and expenses on pro rata basis
<b>HB 198</b>	<b>THOMPSON</b>	<b>SHERIFFS</b> Provides for the payment of insurance premiums for certain retired sheriffs and deputy sheriffs in Richland Parish
<b>HB 258</b>	<b>BRUNEAU</b>	<b>COURTS/CRIMINAL</b> Provides for civil commitment jurisdiction of the Orleans Parish Criminal Court
<b>HB 295</b>	<b>TOWNSEND</b>	<b>COURTS/COURT REPORTERS</b> Provides for court reporter fees in the 39 <sup>th</sup> JDC
<b>HB 306</b>	<b>CAZAYOUX</b>	<b>COURTS/CITY</b> Provides for the imposition of fees in the City Court of Port Allen to fund indigent defense
<b>HB 625</b>	<b>DEWITT</b>	<b>SUPPLEMENTAL PAY</b> Requires certain local governing authorities to issue individual checks for supplemental pay for each eligible employee
<b>HB 642</b>	<b>JEFFERSON</b>	<b>SCHOOLS/BOARDS</b> Relative to School Violence Prevention Training Program
<b>HB 733</b>	<b>DANIEL</b>	<b>BONDS/REVENUE</b> Provides for the dedication of funds for courthouse bonds for the 19 <sup>th</sup> Judicial District Court
<b>HB 750</b>	<b>HUTTER</b>	<b>COURTS/JUSTICE OF PEACE</b> Provides procedures for civil actions in justice of the peace courts
