HB 6	FARRAR	LOCAL OFFL/POLICE CHIEFS Provides for the appointment of the police chief in Ball
HB 17	STRAIN	LAW ENFORCE/OFFICERS Changes the amount of certain payments to survivors of certain firemen and law enforcement officers who lose their lives
HB 40	BRUCE	MUNICIPAL/LAWRASON ACT Authorizes the board of aldermen in the village of Grand Cane, upon recommendation of the mayor, to abolish the office of chief of police
HB 365	FANNIN	FIRE PROTECTION Authorizes certain parish governments to regulate burning of certain materials under certain conditions
HB 586	GREENE	LAW ENFORCE/OFFICERS Provides with respect to financial security for survivors of certain law enforcement officers and firemen
HB 634	WHITE	CIVIL SERVICE/FIRE & POL Authorizes certain municipal fire and police civil service boards to modify certain disciplinary actions against certain employees by issuing a written reprimand to such employees
HB 912	FRITH	FIRE PROTECT/FIREMEN Provides for minimum volunteer fireman training requirements
HB 915	HONEY	CIVIL SERVICE/FIRE & POL Provides for benefits for employees in classified fire service who suffer certain hearing loss
HB 930	HONEY	CIVIL SERVICE/FIRE & POL Provides relative to qualifications of persons admitted to promotional and competitive tests of municipal fire and police civil service boards
HB 937	HONEY	CIVIL SERVICE/FIRE & POL Provides relative to the qualifications of persons placed on employment lists established and maintained by municipal fire and police civil service boards
HB 939	CAZAYOUX	CIVIL SERVICE/FIRE & POL Provides relative to the continuation of the applicability of certain municipal fire and police civil service laws to certain municipalities, parishes, and fire protection districts
HB 994	CAZAYOUX	CIVIL SERVICE/FIRE & POL Relative to municipal fire and police civil service, extends the term of emergency appointments and provides for the term of emergency appointments during a state of emergency
