| <b>HB 21</b>   | <b>LAFLEUR</b>    | <b>CRIME/SEX OFFENSES</b> Extends reporting deadlines of the La. Sexual Assault Task Force  |
| <b>HB 24</b>   | <b>HUNTER</b>     | <b>ALCOHOLIC BEVERAGES</b> Includes correctional facilities in the location ban on selling alcohol  |
| <b>HB 92</b>   | <b>DANIEL</b>     | <b>COURTS</b> Increases recordation fees imposed to defray costs of 19 <sup>th</sup> JDC courthouse   |
| <b>HB 98</b>   | <b>TOWNSEND</b>   | <b>ALCOHOLIC BEVERAGES</b> Requires the granting of a special permit to sell alcohol to the convention center located in the city of Natchitoches                   |
| <b>HB 126</b>  | <b>TOOMY</b>      | <b>JUDGES</b> Provides for the compensation of judges   |
| <b>HB 297</b>  | <b>FAUCHEUX</b>   | <b>ALCOHOLIC BEVERAGES</b> Provides for an exception to the distance restrictions on obtaining an alcoholic beverage permit   |
| <b>HB 350</b>  | <b>POWELL, M.</b> | <b>CLERKS OF COURT</b> Requires the clerk of court for the First Judicial District Court to be ex officio clerk of court for the Juvenile Court for Caddo Parish    |
| <b>HB 351</b>  | <b>POWELL, M.</b> | <b>COURTS/JUVENILE</b> Establishes a judicial expense fund for the juvenile court of Caddo Parish   |
| <b>HB 359</b>  | <b>POWELL, M.</b> | <b>RETIREMENT/JUDGES - CT OFF</b> Authorizes local government or other funds available to the judiciary to be used to pay the retirement contribution for judges    |
| <b>HB 633</b>  | <b>TOWNSEND</b>   | <b>ALCOHOLIC BEVERAGE PERMT</b> Provides for qualifications of applicants for permits   |
| <b>HB 872</b>  | <b>TOWNSEND</b>   | <b>ALCOHOLIC BEVERAGES</b> Prohibits retail outlets from participating in certain promotional practices   |
| <b>HB 941</b>  | <b>ARNOLD</b>     | <b>RECORDS/RECORDATION</b> Requires certain certifications prior to the recordation of conveyances in Orleans Parish  |
| <b>HB 1009</b> | <b>TOOMY</b>      | <b>ALCOHOLIC BEVERAGES</b> Provides relative to wine producers  |
