HB 416	CARTER, K. (TBA)	INSURANCE COMMISSIONER Provides for the appointment by the governor of the commissioner of insurance in lieu of election (Subject to Rules Suspension)
HB 1088	MARCHAND	VOTERS/VOTING Requires the secretary of state to include temporary addresses for certain registered voters in the statewide voter registration database for purposes of mailing information regarding elections or voting
SB 210	JONES	ETHICS Permits supplemental compensation or benefits to be provided to an attorney who is a public employee who is participating in a law school administered Loan Repayment Assistance Program. (gov sig)
SB 263	HINES	ETHICS Excludes pharmaceutical samples from the definition of "thing of economic value" as it relates to the ethics code. (gov sig)
SB 306	JONES	ETHICS Provides that a former member or members of his immediate family or any entity that the former member or his immediate family member has controlling interest of a board or commission may not enter into a contract with that board or commission.
SB 307	JONES	ETHICS Provides that a former employee cannot for a period of two years after termination provide the same services on a contractual basis to, for, or on behalf of his former agency regardless of the parties to the contract.
SB 320	HINES	LOBBYING Excludes from the definition of "executive branch action" a licensed healthcare professional addressing the medical needs of a patient. (gov sig)
SB 541	ULLO	ETHICS Permits a former employee to contract to provide sign language or interpreting services at any time with any agency, including his former agency.
SB 404	HINES	PUBLIC PRINTING Provides relative to the authority of certain state entities to make exceptions regarding printed matter. (gov sig)
HR 2	CROWE	HOUSE/RULES Prohibits a member from changing his vote after the reading and adoption of the Journal for the legislative day that the vote occurred
HR 11	HEBERT	HOUSE/RULES Provides that the motion for final passage, to concur in Senate amendments, or to adopt a conference committee report on the Capital Outlay Bill is not in order under certain circumstances.

HR 12	HEBERT	HOUSE/RULES Requires a display that allows each member in the House Chamber to see the actual tally of votes while the members are casting their votes
