| HB 270 | ARNOLD (TBA) | RETIREMENT/FIREFIGHTERS Provides regarding the payment of interest on DROP account balances (Subject to Rule Suspension) |
| HB 273 | ARNOLD | RETIREMENT/FIREFIGHTERS Limits option of leaving certain retirement benefits to the member or another person or persons to certain beneficiaries |
| HB 300 | DANIEL (TBA) | RETIREMENT/TEACHERS Provides for the reemployment of Louisiana public postsecondary education institution retirees (Subject to Rule Suspension) |
| HB 672 | TRICHE (TBA) | RETIREMENT/TEACHERS Provides with respect to interest credited to a participant's Deferred Retirement Option Plan Account in the Teachers' Retirement System of Louisiana after termination of participation in the plan (Subject to Rule Suspension) |
| HB 1012 | HEATON (TBA) | RETIREMENT/JUDGES - CT OFF Provides for cost-of-living adjustments in the Judges' Noncontributory Plan (Subject to Rule Suspension) |
| HB 1018 | SCHNEIDER (TBA) | RETIREMENT/SHERIFFS FUND Provides with respect to the calculation of benefits for members of the Sheriffs' Pension and Relief Fund (Subject to Rule Suspension) |
| HB 1077 | FARRAR (TBA) | RETIREMENT/TEACHERS Provides with respect to retirement eligibility of a member of the Teachers' Retirement System of La. (Subject to Rule Suspension) |
| SB 37 | GAUTREAUX, B. (TBA) | FIREFIGHTERS RETIREMENT Requires interest applicable to repayment of a refund of contributions to be assessed at the actuarial valuation interest rate. (gov sig) (Subject to Rule Suspension) |
| SB 38 | GAUTREAUX, B. (TBA) | FIREFIGHTERS RETIREMENT Prohibits system membership of a person receiving disability benefits from another public retirement system. (gov sig) (Subject to Rule Suspension) |
| SB 39 | GAUTREAUX, B. (TBA) | FIREFIGHTERS RETIREMENT Allows continuation of survivor benefits upon remarriage of a surviving spouse of a disability retiree. (gov sig) (Subject to Rule Suspension) |
