| HB 37 | MONTGOMERY (TBA) | TAX/SALES-USE-EXEMPT Provides that the state sales and use tax shall not apply to certain consumer purchases of tangible personal property on a certain date (Subject to Rule Suspension) |
| HB 43 | TOWNSEND | TAX/INHERITANCE TAX Deletes requirement that successions be opened within nine months for inheritance tax to be waived |
| HB 155 | ARNOLD | TAX CREDITS Grants refundable income tax credits for musical or theatrical productions and musical or theatrical facility infrastructure projects |
| HB 163 | TOWNSEND | TAX/GASOLINE TAX Provides for a gasoline and special fuels tax credit for volunteer fire departments |
| HB 170 | FARRAR | TAX/SALES & USE Provides for a state sales and use tax exclusion for machinery and equipment for certain utilities |
| HB 225 | ST. GERMAIN | TAX/SALES-USE-EXEMPT Authorizes an annual "sales tax holiday" for the purchase of certain hurricane-preparedness items or supplies |
| HB 256 | RICHMOND | TAX CREDITS Provides relative to the new markets tax credits |
| HB 386 | MORRIS (TBA) | TAX/SALES & USE Provides for an exclusion from state and local sales and use taxes for newspapers (Subject to Rule Suspension) |
| HB 609 | BADON | TAX CREDITS Provides for an income tax credit for certain malpractice insurance premiums paid by certain physicians |
| HB 696 | PINAC | TAX CREDITS Authorizes additional uses of credits under the Louisiana Capital Companies Tax Credit Program |
| HB 709 | TOWNSEND | TAX CREDITS Cane River Heritage Area tax credits |
| HB 716 | TOWNSEND | TAX CREDITS Provides for an income tax credit for donations of certain conservation servitudes |

HB 892	TOWNSEND	TAX CREDITS Provides for extensions of time for certain tax credits
HB 901	RITCHIE	TAX CREDITS Provides a tax credit for certain milk producers
HB 916	FARRAR	TAX/SALES & USE Provides for a state and local sales and use tax exclusion for leases or rentals by manufacturers of pallets which are used in packaging products produced by the manufacturer
HB 940	BURRELL	TAX/INCOME-CREDIT Increases the tax credit for rehabilitation of certain owner-occupied residential or mixed use structures
HB 956	RICHMOND	TAX CREDITS Provides for an income and corporation franchise tax credit for certain businesses exporting cargo through Louisiana ports
