<b>SCR 38</b>	<b>HINES (TBA)</b>	<b>RECOVERY AUTHORITY</b> Approves proposed Amendment No. 13 of Action Plan No. 1 for reallocation of Disaster Recovery Funding from the Long Term Loan Guarantee Program to the Small Firm Loan and Grant Program proposed by the Louisiana Recovery Authority, approved by the governor and the Joint Legislative Committee on the Budget. <b>(Subject to Rule Suspension)</b>
<b>SCR 77</b>	<b>HINES (TBA)</b>	<b>FUNDS/FUNDING</b> Authorizes and instructs the state treasurer to immediately transfer funds from the Louisiana Economic and Port Development Infrastructure Fund to the state general fund. <b>(Subject to Rule Suspension)</b>
<b>SB 53</b>	<b>DUPRE (TBA)</b>	<b>FUNDS/FUNDING</b> Creates Louisiana Coastal Protection and Restoration Financing Corporation to securitize income stream for coastal purposes. (gov sig) <b>(Subject to Rule Suspension)</b>
<b>SB 56</b>	<b>BARHAM (TBA)</b>	<b>GROUP BENEFITS PROGRAM</b> Enables certain state employees and officials to continue membership in State Group Benefits Insurance Plan for payment of 100 % of premium after state service ends. (gov sig) <b>(Subject to Rule Suspension)</b>
<b>SB 103</b>	<b>JACKSON, L. (TBA)</b>	<b>REGISTRARS OF VOTERS</b> Provides relative to the compensation of registrars of voters and their chief deputies and confidential assistants. (7/1/07) <b>(Subject to Rule Suspension)</b>
<b>SB 123</b>	<b>ULLO (TBA)</b>	<b>NATURAL RESOURCES DEPT</b> Changes the termination date of the Underwater Obstruction Removal Fund from 2007 to 2012. (6/29/07) <b>(Subject to Rule Suspension)</b>
<b>SB 136</b>	<b>JACKSON, L. (TBA)</b>	<b>PUBLIC CONTRACTS</b> Increases the maximum proposal amount for social service contracts. <b>(Subject to Rule Suspension)</b>
<b>SB 158</b>	<b>MARIONNEAUX (TBA)</b>	<b>MILITARY AFFAIRS</b> Provides for insurance allowances for Louisiana National Guard members. (gov sig) <b>(Subject to Rule Suspension)</b>

- SB 164**      **CASSIDY (TBA)**      **HEALTH/HOSPITALS DEPT** Authorizes the Louisiana State Board of Medical Examiners to retain the proceeds from improvements to immovable property and the sale and lease of land. (gov sig) **(Subject to Rule Suspension)**
- SB 236**      **SMITH, MIKE (TBA)**      **PUBLIC SFTY/CORRECT DEPT** Provides for equal payments by youth services, office of youth development, to non-state owned secure detention facilities housing children in the process of being placed in a secure or non-secure facility. (gov sig) **(Subject to Rule Suspension)**
- SB 238**      **MCPHERSON (TBA)**      **FUNDS/FUNDING** Establishes the Health Care Redesign Fund in the state treasury. (gov sig) **(Subject to Rule Suspension)**
- SB 240**      **AMEDEE (TBA)**      **COMMERCIAL REGULATIONS** Requires that certain state-funded major facility projects meet energy efficient standards. (gov sig) **(Subject to Rule Suspension)**
- SB 286**      **HEITMEIER (TBA)**      **LAW ENFORCEMENT** Extends eligibility for supplemental pay for police officers and firefighters of certain agencies servicing levees, waterways and riverfront areas in municipalities with a population exceeding 450,000. (See Act) **(Subject to Rule Suspension)**
- SB 287**      **HEITMEIER (TBA)**      **FUNDS/FUNDING** Increases state supplemental pay for firefighters and certain law enforcement officers. (7/1/07) **(Subject to Rule Suspension)**
