| HCR 3 | FRITH | RETIREMENT/COLAS Grants approval of a cost-of-living increase requested by the board of trustees of the Teachers' Retirement System of Louisiana (TRSL) and of an additional COLA, effective July 1, 2007 |
| HB 344 | HILL (TBA) | RETIREMENT/ASSESSORS Establishes the Back-Deferred Retirement Option Plan (Back-DROP) and repeals the Deferred Retirement Option Plan (DROP) for the Assessors' Retirement Fund (Subject to Rule Suspension) |
| HB 425 | ARNOLD (TBA) | RETIREMENT/LOCAL Relative to the Firefighters' Pension and Relief Fund in the City of New Orleans, provides relative to military service credit, vesting requirements, optional allowances, beneficiaries, and the Deferred Retirement Option Plan (Subject to Rule Suspension) |
| HB 426 | ARNOLD (TBA) | RETIREMENT/LOCAL Relative to the Firefighters' Pension and Relief Fund in the city of New Orleans and optional allowances for deceased members, removes a requirement for two years of marriage for certain surviving spouse's benefits (Subject to Rule Suspension) |
| HB 427 | ARNOLD (TBA) | RETIREMENT/LOCAL Relative to the Firefighters' Pension and Relief Fund in the City of New Orleans, provides for service credit and benefits (Subject to Rule Suspension) |
| HB 580 | LABRUZZO (TBA) | RETIREMENT/STATE-STWIDE Provides relative to interruptions in post-DROP employment periods occasioned by Hurricanes Katrina and Rita for members of Louisiana State Employees' Retirement System (Subject to Rule Suspension) |
| HB 845 | DURAND (TBA) | RETIREMENT/STATE EMPS Provides for a higher benefit accrual rate for certain adult probation and parole officers and for actuarial funding for such benefit (Subject to Rule Suspension) |

SCR 3	GAUTREAUX, B.	TEACHERS RETIREMENT Authorizes the board of trustees of the Teachers' Retirement System of Louisiana to grant cost-of-living increases payable from the employee experience account.
SB 83	GAUTREAUX, B.	STATE POLICE RET FUND Provides a cost-of-living adjustment for certain beneficiaries with twenty years of service credit. (6/30/07)
SB 96	AMEDEE	STATE EMPLOYEE RET Provides relative to reemployment of retirees. (7/1/07)
SB 116	THEUNISSEN	RETIREMENT SYSTEMS Authorizes the LASERS and Teachers' boards of trustees to grant a supplemental cost-of-living increase of 0.5%, beginning July 1, 2007, from their respective experience accounts for a maximum of 3.0%, which would otherwise be limited to 2.5%. (6/30/07)
