| HB 234 | CRANE (TBA) | SHERIFFS Provides for limitations on fees charged in civil matters (Subject to Rule Suspension) |
| HB 242 | DAMICO | CLERKS OF COURT Provides relative to the electronic filing of certain instruments |

LAW ENFORCE/OFFICERS Provides relative to rights of certain law enforcement officers while under investigation

HB 441 LAFLEUR

MILITARY AFFAIRS Provides for various changes to the laws relating to the administration of the Military Department

HB 707 HARRIS

INSURANCE CLAIMS-ADJUSTR Establishes emergency authority for claims adjusters to enter into a disaster area immediately following a catastrophe

HB 740 DORSEY

CRIME/SEX OFFENSES Provides for restrictions for emergency shelter or housing of sex offenders
