HB 360	TOWNSEND	CONTRACTS Provides relative to state contracts for provision and processing of credit and debit cards or devices by public institutions of higher education
HB 362	TOWNSEND	FISCAL CONTROLS (Constitutional Amendment) Provides that legislation with a negative fiscal effect, when considered with appropriations, shall not exceed the expenditure limit
HB 383	DOWNS	FUNDS/FUNDING Creates the Windfall Highway, Infrastructure, and Protection (WHIP) Fund
HB 385	BALDONE	INSURANCE/PROPERTY Provides for the dedication of certain insurance premium taxes to the Louisiana Insurance Catastrophe Fund created in the state treasury

HB 388	GUILLORY, MICKEY	FUNDS/FUNDING Reallocates sales tax on room rentals in St. Landry Parish to capital projects related to tourism
HB 403	CAZAYOUX	ELECTIONS Provides for the number of authorized state employee positions in the office of each registrar of voters
HB 409	CAZAYOUX	PROCUREMENT Exempts from the state procurement code inter-institutional agreements of Louisiana higher education entities when they involve co-owners of intellectual property
HB 450	BURNS	FUNDS/FUNDING Establishes the Department of Health and Hospitals' Facility Support Fund to provide with respect to the proceeds from the sale or lease of property operated by the Department of Health and Hospitals
HB 459	ARNOLD	APPROPRIATIONS Appropriates funds for payments against the Unfunded Accrued Liability of certain public retirement systems
HB 463	ARNOLD	APPROPRIATIONS Appropriates funds for the operation of the Algiers/Canal Street ferry
HB 506	ALARIO	APPROPRIATIONS Appropriates from 2007-2008 Fiscal Year for certain payments for uncompensated care costs

HB 667	TOWNSEND	CAPITAL OUTLAY (Constitutional Amendment) Requires a certain percentage of certain non-recurring funds to be spent on highway projects

HB 814	LAFLEUR	FUNDS/FUNDING Creates and establishes the Louisiana Roads Fund and dedicates certain sales and use tax revenue to the fund
HB 857	SCHNEIDER	APPROPRIATIONS/SUPPLEML Supplemental appropriation to provide for payments against the initial Unfunded Accrued Liability of the public retirement system
HB 873	BADON	TRANSPORTATION Provides for distribution and dedication of state revenue
HB 886	QUEZAIRE	FUNDS/FUNDING Establishes the Louisiana Transportation Center Fund in the state treasury
