HR 1	SCHNEIDER (TBA)	INSURANCE/PROPERTY Directs the House Committee on Insurance to hold hearings on the Louisiana Citizens Property Insurance Corporation (Subject to rules suspension)
HCR 9	CARTER, K.	INSURANCE/HEALTH Continues the Task Force on the Working Uninsured
HB 277	BOWLER	INSURANCE/AUTOMOBILE Exempts certain vehicles from the requirement for compulsory motor vehicle liability security
HB 402	GUILLORY, ELCIE	INSURANCE/PROPERTY Provides relative to the membership of the board of directors for the Louisiana Citizens Property Insurance Corporation
HB 431	FARRAR	INSURANCE Changes the governor's appointments to the governing body of the Louisiana Citizens Property Insurance Corporation
HB 470	LAMBERT (TBA)	INSURANCE/AUTOMOBILE Increases the minimum liability limit on automobile insurance policies (Subject to rules suspension)
HB 528	MORRELL	INSURANCE/RATES Eliminates the Louisiana Citizens Property Insurance Corporation's noncompetitive rating structure for residential property insurance policies in any noncompetitive market and provides for the use of actuarially sound rates
HB 549	KATZ (TBA)	CREDIT/CONSUMER Provides for cancellation of certain policies by an insurance premium finance company (Subject to rules suspension)
HB 562	JEFFERSON	INSURANCE/PROPERTY Temporarily suspends the noncompetitive rating structure of the Louisiana

Citizens Property Insurance Corporation and provides for the use of actuarially justified rates

HB 654 LORUSSO

INSURANCE/PROPERTY Provides for a change in the membership of the board of directors of the Louisiana Citizens Property Insurance Corporation

HB 717 BAYLOR

INSURANCE/POLICIES Provides for the elimination of contents coverage on residential properties following a catastrophe

HB 782 HEBERT

INSURANCE/RATES Provides for the removal of Louisiana Citizens Property Insurance Corporation's noncompetitive rating structure in any parish where the commissioner of insurance deems there is no competition

HB 825 LAFONTA

INSURANCE Eliminates the Louisiana Citizens Property Insurance Corporation's noncompetitive rating structure in any parish where the corporation is writing a majority of residential property insurance policies
