HB 676	SMILEY	BOARDS/COMMISSIONS Provides for changes to the Louisiana Recreational and Used Motor Vehicle Commission
HB 701	WILLIAMS	INSURANCE Provides for changes to the Residential Mortgage Lending Act
HB 769	SMITH, GARY	AMUSEMENTS/FIREWORKS Limits the sale of fireworks in certain circumstances
HB 783	KENNARD	MTR VEHICLE/DISMANTLERS Provides for the disposal of certain motor vehicles
HB 843	DEWITT	AMUSEMENTS/TICKETS Provides for changes with respect to the resale of event tickets
HCR 28	MONTGOMERY	RACING/COMMISSION Urges and requests the Louisiana State Racing Commission to review and revise the current jockey fee schedule
HCR 100	ALEXANDER	ECONOMIC DEVELOPMENT Requests the Department of Economic Development to refer to the "Southern Region" as the official title to eleven states in the South
SB 137	FONTENOT (TBA)	MOTOR VEHICLES Removes requirement of a buyer's identification card for Internet based salvage pool or salvage disposal sales of motor vehicles by a used motor vehicle dealer. (see Act) (Subject to Rule Suspension)

- SB 142 DUPLESSIS** **FINANCIAL INSTITUTIONS** Provides that certain criminal history records be made available to the office of financial institutions. (gov sig)
- SB 245 GAUTREAUX, N.** **HORSE RACING** Provides for proper venue for lawsuits against the Louisiana State Racing Commission and for the allocation of certain proceeds from exotic wagering during a race meeting. (See Act)
- SB 253 HOLLIS** **BANKS/BANKING** Provides with respect to financing single premium insurance in connection with residential mortgage loans. (gov sig)
- SB 254 HOLLIS** **COMMERCIAL REGULATIONS** Provides relative to the Louisiana Consumer Credit Law. (gov sig)
- SB 256 HOLLIS** **MOTOR VEHICLES** Authorizes collection of a security and compliance fee to be collected by an automobile dealer to comply with federal and state laws. (gov sig)
- SB 304 DUPLESSIS** **COMMERCIAL REGULATIONS** Provides relative to mutual savings banks. (gov sig)
