| HCR 109 | JEFFERSON (TBA) | BONDS Requests the State Bond Commission to study the feasibility of providing the full faith and credit for claims and legal obligations of La. Citizens Property Insurance Corporation (Subject to Rule Suspension) |
| HB 2 | TOWNSEND | CAPITAL OUTLAY Provides for the comprehensive capital outlay budget |
| HB 3 | TOWNSEND | CAPITAL OUTLAY Provides for the Omnibus Bond Act |
| HB 123 | KLECKLEY | TAX/OCCUPATIONAL Provides for an exclusion for gasoline sales from the definition of gross sales |
| HB 189 | GRAY | TAX CREDITS Authorizes a tax credit for foster parents |
| HB 272 | HUTTER | TAX CREDITS Provides for an income and corporation franchise tax credit for expenses incurred in retrofitting a structure to meet State Uniform Construction Code standards |
| HB 287 | MONTGOMERY | TAX CREDITS Provides for an income and corporation franchise tax credit for ad valorem taxes paid by certain barge line, towing, and other water transportation companies |
| HB 297 | HUTTER | TAX CREDITS Provides tax credits for certain new, expanding, and returning businesses in St. Bernard Parish |
| HB 299 | SCHNEIDER (TBA) | TAX/EXCISE Reduces the excise tax on certain low-content alcoholic beverages for certain manufacturers or brewers (Subject to Rule Suspension) |
| HB 359 | TOWNSEND (TBA) | TAX EXEMPTIONS Provides relative to tax exemptions and credits in cultural product districts (Subject to Rule Suspension) |
| HB 410 | GRAY | TAX CREDITS Authorizes a tax credit for kinship caregivers |

HB 495	TOWNSEND (TBA)	TAX EXEMPTIONS Authorizes the exclusion of certain income derived from artistic works from state income taxation (Subject to Rule Suspension)
HB 508	FAUCHEUX	TAX/SALES & USE Reinstates the exemption for certain utilities for all four percent of the state sales and use tax
HB 521	JEFFERSON (TBA)	TAX CREDITS Provides tax credit for and establishes the "Housing Louisiana's Workforce Tax Credit Act" (Subject to Rule Suspension)
HB 543	BARROW (TBA)	PUBLIC BLDGS/GROUNDS-ST Requires certain building standards for certain facilities built or funded by the state (Subject to Rule Suspension)
HB 548	GRAY	TAX CREDITS Establishes the Green Building Tax Credit Program
HB 568	TOWNSEND (TBA)	TAX EXEMPTIONS Authorizes a culinary arts and food science investor tax credit (Subject to Rule Suspension)
HB 757	SALTER (TBA)	TAX/SALES & USE Includes certain machinery and equipment used primarily to produce a news publication within the state sales and use tax exclusion for manufacturing machinery and equipment (Subject to Rule Suspension)
HB 795	SALTER	SMALL BUSINESS Provides relative to the Louisiana Community Development Financial Institution Act
HB 826	GUILLORY, ELBERT	TAX/AD VALOREM TAX Provides for an updated statewide criteria for assessing the value of business assets
HB 921	LABRUZZO	TAX CREDITS Provides a tax credit for purchase of computer equipment for use in medical offices located in medically underserved areas
HB 922	LABRUZZO	TAX CREDITS Provides for an individual or corporate income tax deduction for certain physicians and health care providers located in medically underserved areas
HB 929	TRICHE (TBA)	TAX CREDITS Provides for a tax credit for overpayments made by certain taxpayers under the Inventory Tax Credit (Subject to Rule Suspension)
