HCR 3	ROBIDEAUX	CRIMINAL/PROCEDURE Authorizes and directs the Louisiana State Law Institute to review the provisions of Code of Criminal Procedure Art. 814(C) regarding responsive verdicts
HB 46	MILLS	CONTROLLED SUBSTANCES Reorganizes Schedules I, II, III, and V of the Uniform Controlled Dangerous Substances Law to make those provisions consistent with federal law
HB 96	WHITE	CRIME Creates the crime of home invasion
HB 118	BALDONE	CORRECTIONS Amends the definition of "contraband" with regard to items prohibited in state correctional facilities
HB 121	BALDONE	CORRECTIONS Provides relative to the rate of "good time" and jail credit that inmates may receive
HB 123	WOOTON	CORRECTIONS/PRISONERS Provides for the release of certain information pertaining to a prisoner's activities while incarcerated
HB 125	GUILLORY, ELBERT	CORRECTIONS/PRISONERS Provides with respect to the permissible use of interest earned from inmates' compensation accounts
HB 127	WOOTON	CORRECTIONS Provides relative to eligibility for intensive incarceration and intensive parole supervision
HB 148	HAZEL	CRIME Amends cruelty to juvenile provisions
HB 163	LIGI	CRIME Creates the crime of criminal damage to property by defacing with graffiti
HB 201	BALDONE	CRIMINAL/PROCEDURE Expands the list of crimes which are not subject to sentence suspension
HB 206	WOOTON	CORRECTIONS Provides for the entity receiving supervised release payments
HB 218	GUILLORY, ELBERT	CRIMINAL/SENTENCING Expands the list of crimes for which a criminal sentence may not be suspended

HB 289	WOOTON	PARDON/PAROLE Directs the Louisiana State Law Institute to redesignate the provisions of law regarding intensive incarceration and intensive parole supervision as a separate statute
HB 434	WOOTON	CRIMINAL/PENALTIES Provides with respect to securities violations
HB 531	WOOTON	CORRECTIONS Amends provisions of law regarding the definition of a technical violation for the purposes of revoking probation or parole
HB 603	LOPINTO	CRIME/ABUSE Amends provision of law regarding penalties for domestic abuse battery under certain circumstances
HB 705	HARDY	CRIMINAL/PROCEDURE Amends provisions of law regarding individual access to bureau
HB 748	WOOTON	CORRECTIONS Provides for the reimbursement to private health care providers for costs of extraordinary medical expenses of inmates under certain circumstances
HB 751	WOOTON (TBA)	CRIME/RACKETEERING Adds the crime of identity theft to the Louisiana Racketeering Act (Subject to Rule Suspension)
