HCR 14	GALLOT	CAMPAIGN FINANCE Suspends the provisions of R.S. 18:1483(14)(c) and 1501.2 as enacted by Act No. 26 of the 2008 First Extraordinary Session relative to campaign finance
HCR 33	BARROW (TBA)	VOTERS/VOTING Requests the secretary of state's voter outreach division to strengthen its efforts relative to voter education and promoting and facilitating voter registration throughout the state (Subject to Rule Suspension)
HB 106	MORRELL	ELECTION OFFENSES Prohibits certain false statements by a candidate
HB 165	MORRELL	VOTING/REGISTRATION Provides relative to the change of address for purposes of voter registration
HB 216	GALLOT	REAPPORTIONMENT/JUDGES Provides for the districts and election sections for the Court of Appeal for the Second Circuit
HB 281	JONES, ROSALIND	ELECTIONS/CAMPAIGNS Prohibits a public servant from creating a public service announcement during time periods around an election if such public servant has qualified to be a candidate in such election
HB 295	GISCLAIR	CAMPAIGN FINANCE Requires certain political advertisements and communications made within 30 days of an election to include a statement identifying the person responsible for the advertisement and stating whether it was authorized by the candidate or his committee
HB 464	HARDY	VOTERS/VOTING Provides for protection of voter registration information
HB 830	LAFONTA	VOTING/REGISTRATION To require approval by the House and Senate governmental affairs committees prior to cancellation of the registrations of inactive voters

HB 854	LAMBERT	JUDGES Provides for geographical election sections for first district of First Circuit Court of Appeals
HB 876	RICHMOND	MINORITIES Creates the Louisiana Council on Social Status of Black Men and Boys
HB 908	RICHMOND	ELECTIONS Changes the voter registration deadline from thirty to ten days prior to the election
HB 990	BARROW	VOTING/REGISTRATION Allows voter registration in the office of a public high school guidance counselor
HB 998	PETERSON	VOTING/REGISTRATION Requires the secretary of state to provide for the attachment of voter registration applications to provisional ballots
HB 1000	LAFONTA	VOTING/REGISTRATION Requires approval by the legislature prior to cancellation of the registrations of inactive voters
HB 1011	LAFONTA	VOTERS/VOTING Requires certain reports regarding satisfaction of order of imprisonment for conviction of a felony
HB 1044	ABRAMSON	ELECTION OFFENSES Requires that campaign communications by telephone include certain identification of the source of the call
