| HB 108 | ARNOLD | RETIREMENT/STATE SYSTEMS Makes permanent certain requirements that state retirement systems direct portions of certain types of investments through Louisiana broker-dealers |
| HB 227 | ROBIDEAUX (TBA) | RETIREMENT/FIREFIGHTERS Allows continuation of survivor benefits upon remarriage of a surviving spouse of a disability retiree (Subject to Rule Suspension) |
| HB 228 | ROBIDEAUX | RETIREMENT/FIREFIGHTERS Provides relative to the quorum and voting requirements of the board of trustees of the Firefighters' Retirement System |
| HB 229 | ROBIDEAUX | RETIREMENT/STATE EMPS Provides with respect to the number of years and type of service for retirement eligibility in the corrections secondary component of the La. State Employees' Retirement System |
| HB 231 | DOERGE (TBA) | RETIREMENT/FIREFIGHTERS Exempts Firefighters' Retirement System from the requirement of constructively engaging certain companies with facilities or employees or both in prohibited nations (Subject to Rule Suspension) |
| HB 521 | MONTOUCET | RETIREMENT/MUNICIPAL POL Relative to the Municipal Police Employees' Retirement System, increases non-service disability retirement eligibility from five years to 10 years of creditable service |
| HB 740 | LIGI | RETIREMENT BENEFITS (Constitutional Amendment) Provides for forfeiture of public retirement benefits by certain persons who are convicted of felony acts associated with their positions |
| HB 783 | CONNICK | RETIREMENT BENEFITS (Constitutional Amendment) Authorizes the forfeiture of certain school employee related retirement benefits for those found guilty of a sex crime against a student |

| HB 976 | ARNOLD | RETIREMENT/LOCAL Increases the accrual rate of retirement benefits for members with twelve or more years of service in the Firefighters' Pension and Relief Fund in the city of New Orleans |
| HB 1006 | ARNOLD (TBA) | RETIREMENT/LOCAL Allows certain members of the Firefighters' Pension and Relief Fund in the city of New Orleans to participate retroactively in the deferred retirement option plan (Subject to Rule Suspension) |
| HB 1013 | CONNICK | RETIREMENT BENEFITS Requires the forfeiture of retirement benefits of certain public school teachers and employees if found guilty of a sex crime against a student |
| HB 1022 | LIGI | RETIREMENT BENEFITS Requires forfeiture of public retirement benefits by certain persons convicted of certain state or federal felony acts associated with his public service |
| HB 1078 | ROBIDEAUX (TBA) | RETIREMENT/STATE EMPS Provides with respect to the computation of benefits for non-qualified participants in the Louisiana State Employees' Retirement System (Subject to Rule Suspension) |
