HB 383	LEBAS	TAX/SALES-USE, LOCAL Requires health insurance issuers to pay local sales and use taxes on prescription drugs and pharmacist services under certain circumstances and provides penalties for violations
HB 582	TUCKER	CAPITAL OUTLAY Revises the capital outlay process and the priorities and other content of the Capital Outlay Bill
HB 1156	ABRAMSON	STATE GRANTS Establishes the Grants for Grads Program and the Grants for Grads Fund for assistance to Louisiana college graduates in the purchase of their first home
HB 1209	GREENE	CAPITAL OUTLAY Revises the capital outlay process and the priorities and other content of the Capital Outlay Bill
SB 7	MURRAY (TBA)	TAX/AD VALOREM Provides for procedures and time periods in Orleans Parish related to inspection of assessment lists, review and complaints concerning assessments, certifications of such lists, and hearings of appeals of assessments. (1/1/09) (Subject to Rule Suspension)
SB 109	MORRISH (TBA)	CAPITAL OUTLAY Increases the amount for projects for minor repairs, renovation, or construction of facilities or purchase of land and facilities which may be undertaken outside of the capital outlay process by higher education, and increases the amount exempt from professional services rules for contracts related to such activities. (8/15/08) (Subject to Rule Suspension)
SB 329	ADLEY (TBA)	TAX/SALES Provides for proceedings, including an arbitration proceedings, to determine whether a taxpayer or a tax collector is asserting an interpretation of a rule, regulation, policy, or interpretation of sales tax law, or ordinance which violates the requirement in the Uniform Local Sales Tax Code. (gov sig) (Subject to Rule Suspension)
SB 520	MORRISH (TBA)	TAX/TAXATION Prohibits an action to collect a tax applicable to movables on certain purchases of

certain manufactured homes between 9/1/05 and 12/31/06 used as residences in certain parishes which were impacted by hurricanes Katrina and Rita, if the basis of such action is the date upon which a declaration of immovability is recorded in the conveyance or mortgage records. (7/1/08)

SB 569 MORRISH

FUNDS/FUNDING Creates the Manufactured Home Tax Fairness Fund to be used for refunds of tax, penalty, and interest paid on purchases from September 1, 2005 through December 31, 2006 of manufactured homes used solely as residential housing for which a declaration of immovability is recorded, in certain parishes severely impacted by hurricanes Katrina and Rita. (7/1/08)

SB 796 MCPHERSON

FUNDS/FUNDING Excludes debt secured by a statewide tax or statewide assessment approved by the voters from the state debt limit. (2/3 - CA7s6(F)) (gov sig)

SB 808 MARIONNEAUX

CAPITAL OUTLAY Provides relative to capital outlay. (2/3-CA7s11) (7/1/08)
