| HB 89 | DOERGE | RETIREMENT/DROP Provides relative to the payment of interest on DROP account balances for DROP participants in the Louisiana State Employees' Retirement System and the Teachers' Retirement System of Louisiana |
| HB 710 | GREENE | RETIREMENT/MUNICIPAL POL Relative to the Municipal Police Employees' Retirement System, to provide for the investment of DROP funds by plan participants |
| HB 983 | HARRISON | RETIREMENT/TEACHERS Relative to the Teachers' Retirement System of Louisiana, provides with respect to unused annual and sick leave |
| HB 1233 | ROBIDEAUX | RETIREMENT/TEACHERS Provides relative to membership in Teachers' Retirement System of Louisiana for certain alien teachers working under J visas |
| SB 50 | CROWE | MUNICIPAL EMPLOYEE RET Provides for change of beneficiary under certain circumstances. (7/1/08) |
| SB 78 | HEBERT | CLERKS OF COURT Provides relative to eligibility to enter the Clerks' of Court Retirement and Relief Fund Deferred Retirement Option Plan. (7/1/08) |
| SB 181 | CASSIDY | RETIREMENT SYSTEMS Allows boards of trustees to require payment of additional employer contributions. (6/30/08) |
| SB 195 | HEBERT | CLERKS OF COURT RET Provides relative to disability retirement for the Clerks' of Court Retirement and Relief Fund. (7/1/08) |
| SB 201 | ALARIO | SCHOOL EMPLOYEES RET Includes pay to school bus drivers for certain school-related extracurricular activities in the definition of earnable compensation. (7/1/08) |

- SB 315** **NEVERS** **RETIREMENT BENEFITS** Provides for enhanced benefits for peace officers employed as arson investigators in the fire marshal's office. (7/1/08)
- SB 391** **GRAY** **LOCAL RETIREMENT** Increases the annual accrual rate for certain New Orleans firefighters to three and one-third percent. (7/1/08)
- SB 394** **GRAY** **FIREFIGHTERS RETIREMENT** Deletes provision requiring that a member have a career-ending service injury in order to enter retroactively the Deferred Retirement Option Plan for New Orleans firefighters. (7/1/08)
- SB 478** **MURRAY** **SHERIFFS PEN/RELIEF FUND** Provides for purchase of service credit in the Sheriffs' Pension and Relief Fund. (7/1/08)
