| <b>HB 657</b>  | <b>TRAHAN</b>       | <b>SCHOOLS/EMPLOYEES</b> Prohibits requiring school employees to complete paperwork if the information provided for in such paperwork is available from another source  |
| <b>HB 1037</b> | <b>TRAHAN</b>       | <b>TEACHERS/SALARY SCHEDULE</b> Provides relative to salary differential amounts for teachers having certain advanced degree  |
| <b>HB 1133</b> | <b>DOWNS</b>        | <b>SCHOOLS</b> Provides relative to the habitual tardiness of students, including penalties for certain violations by parents and other persons having charge of habitually tardy students                        |
| <b>HB 1145</b> | <b>FOIL</b>         | <b>STUDENT/TUITION</b> Authorizes the LSU Bd. of Supervisors to impose specific increases in tuition and nonresident attendance fee amounts for students at the Paul M. Hebert Law Center                         |
| <b>HB 1256</b> | <b>DOWNS</b>        | <b>SCHOOLS/BOARDS</b> Provides relative to training and instruction for public school board members and requires that a certain number of hours focus on certain topics   |
| <b>HB 1261</b> | <b>HINES</b>        | <b>HEALTH</b> Prohibits K-12 public schools from serving to students food containing trans fat  |
| <b>HB 1278</b> | <b>WADDELL</b>      | <b>STUDENT/LOANS-SCHOLARSHIP</b> Permits use of a TOPS-Tech Award at certain schools having a certificate of registration issued by the Bd. of Cosmetology and proprietary schools licensed by the Bd. of Regents |
| <b>HB 1314</b> | <b>JACKSON, M.</b>  | <b>COLLEGES/SOUTHERN U</b> Authorizes the Southern University Board of Supervisors to impose specific tuition increases at the law center   |
| <b>HB 463</b>  | <b>TRAHAN</b>       | <b>SCHOOLS/DISTRICTS</b> Provides relative to the retention period for certain schools transferred to the Recovery School District and required reporting relative thereto  |
| <b>HCR 65</b>  | <b>TUCKER (TBA)</b> | <b>EDUCATION</b> Requests the Bd. of Regents to consider specific factors in developing the postsecondary education funding formula and   |

budget recommendations for FY 2009-2010 and subsequent years relative to the LCTCS (**Subject to rule suspension**)
