HB 639	RICHMOND	COURTS Provides relative to the consolidation of the court officers of the parish of Orleans
HB 659	HARDY	COURTS/APPELLATE Changes the domicile of the Court of Appeal for the Third Circuit to Lafayette
HB 838	TUCKER	HEALTH/EMERG MED SERVICE Requires a review of health care services rendered during an emergency prior to criminal prosecution
HB 1152	RICHMOND	DISTRICT ATTORNEYS/ASST Provides for the omnibus new assistant district attorney positions for the various judicial districts in the state
HB 1214	SCHRODER	CHILDRENS CODE Provides for multidisciplinary interaction in child abuse and neglect cases
HB 1257	ABRAMSON	COURTS Provides that before the legislature enacts bills changing the elections sections and precincts of a court, the proposed changes be submitted to the Judicial Council for their recommendation
HB 1258	EDWARDS	REAL ESTATE/APPRAISERS Increases the fees for appraisals conducted for a sheriff's sale
HB 1267	MONTOUCET	COURTS/CITY Authorizes an Increase in compensation for the marshal of the City Court of Rayne
HB 1277	WHITE	COURTS Provides that the increased costs for recordings and filings in the 19 th JDC shall not apply to successions
HB 1286	LAMBERT	CIVIL/APPEALS Provides for the jurisdiction of the trial court
SB 55	MORRISH	COURTS Increases the jurisdictional limit for civil suit filing in the City Court of Jennings to \$30,000. (8/15/08)
SB 91	QUINN (TBA)	JUDGES Provides for two additional judgeships in the Twenty-Second Judicial District Court with specified jurisdiction. (gov sig) (Subject to Rule Suspension)
SB 101	MORRISH	COURTS Provides for the transfer of surplus funds from the City Court of Jennings' civil fee account to the court's general operational fund. (8/15/08)
SB 166	MURRAY	COURTS Provides that judges elected in 2009, and elected and appointed magistrates, for the 41 st Judicial District Court shall automatically revert to judges and magistrates of the civil and criminal courts of Orleans Parish should the legislation creating the 41 st JDC be held unconstitutional. (gov sig)

SB 406	WALSWORTH	PUBLIC SFTY/CORRECT DEPT Requires preparation of a report on salary schedules no later than the fifteenth day of November prior to a fiscal session.
SB 579	MURRAY	CLERKS OF COURT Provides relative to the 41 st Judicial District Clerk of Court. (See Act)
SB 613	MURRAY (TBA)	COURTS Provides relative to the district courts in the parish of Orleans. (8/15/08) (Subject to Rule Suspension)
SB 624	MURRAY	COURTS Requires a separate environmental docket for the civil district court for the Forty-First Judicial District and provides for enforcement of health, safety, and welfare ordinances in Orleans Parish. (1/01/09)
SB 625	MURRAY (TBA)	COURTS Provides relative to district court judges and magistrates in Orleans Parish. (gov sig) (Subject to Rule Suspension)
