| HB 131 | RICHMOND | PARDON/PAROLE Provides that DPS&C shall pay sheriffs for keeping and feeding any individual who has a pending parole or probation revocation hearing |
| HB 638 | LABRUZZO | PROCUREMENT Requires certain fuel efficiency standards for state vehicles |
| HB 734 | TRAHAN | STUDENT/TUITION Authorizes the public postsecondary education management boards to establish tuition and mandatory fee amounts for resident students |
| HB 1135 | ST. GERMAIN | NATURAL RESOURCES DEPT Provides for the Atchafalaya Basin Program |
| SCR 12 | MICHOT | FISCAL CONTROLS Requests the chief information officer of the state to study the state's reliance on and costs associated with high volume, basic computing systems. |
| SCR 14 | MORRISH | ADMINISTRATION DIVISION Requests the division of administration to permit input from all executive directors of the various councils on aging prior to any decision to move the various councils on aging from the office of the governor to the Department of Health and Hospitals. |
| SCR 47 | GRAY | FUNDS/FUNDING Requests the governor and the Board of Regents to support continued operational and capital outlay funding needs for public higher education institutions in Southeast Louisiana. |
| SB 94 | THOMPSON | TAX/TAXATION Increases the portion of the severance tax on timber allocated to the Forestry Productivity Fund, from seventy-five percent to one hundred percent. (7/1/08) |
| SB 456 | MICHOT | FUNDS/FUNDING Provides relative to the 2004 Overcollections Fund. (gov. sig) |

SB 489	THOMPSON	AGRICULTURE/FOREST DEPT Provides an exemption for Department of Agriculture and Forestry aircraft from maintenance regulation by the aviation unit of the division of administration. (gov sig)
SB 530	MICHOT	FISCAL CONTROLS Relative to the interim emergency board, provides for agency notification. (gov sig)
SB 542	SMITH, JOHN	FUNDS/FUNDING Provides for the use of certain collections in Vernon Parish. (gov sig)
SB 559	MARIONNEAUX	LEGISLATIVE AGENCIES Requires compliance with audit requirements to receive appropriated funds. (8/15/08)
SB 601	MICHOT	FUNDS/FUNDING Creates the Post Employment Benefits Trust Fund in the State Treasury. (7/1/08)
