| <b>SB 229</b>  | <b>MOUNT</b>       | <b>HEALTH CARE</b> Provides for health care facilities violations and penalties. (gov sig)  |
| <b>SB 312</b>  | <b>MOUNT</b>       | <b>PUBLIC HEALTH</b> Provides for requirements for water fluoridation. (gov sig)  |
| <b>SB 332</b>  | <b>THOMPSON</b>    | <b>HEALTH/HOSPITALS DEPT</b> Creates the Health Care Information Technology and Infrastructure Advisory Collaborative. (gov sig)  |
