<b>SB 240</b>	<b>MOUNT</b>	<b>LOCAL OFFICIALS</b> Authorize Calcasieu Parish to create waterworks subdistricts and to expand the membership of the boards of commissioners of waterworks districts. (8/15/09)
<b>SB 262</b>	<b>MARTINY</b>	<b>LOCAL AGENCIES</b> Provides relative to commissioners to local housing authorities. (8/15/09)
