HB 118	SMITH, JANE	CRIMINAL/PROCEDURE Removes requirement that a substitute attorney appointed for a district attorney who is recused be from the same judicial district as the district attorney who has been recused
HB 125	RITCHIE	COURTS/COURT COSTS Increases court costs for the marshal of the City Court of Bogalusa

HB 136	GUINN	COURTS/COURT COSTS Increases court costs in criminal cases for the 31 st JDC
HB 148	STIAES	SHERIFFS Consolidates the offices of the criminal sheriff and the civil sheriff of Orleans Parish in 2010
HB 150	MONTOUCET	CLERKS OF COURT Provides relative to an automobile expense allowance for the clerks of court of the district courts in Acadia Parish and Iberia Parish
HB 160	DANAHAY	COURTS/MAYORS Authorizes the mayor to appoint an attorney to preside over the mayor's court in DeQuincy
HB 165	EDWARDS	MILITARY AFFAIRS Provides relative to the use of state war veterans homes and care facilities
HB 197	DOERGE	COURTS/CITY Provides for an increase in fees for the marshal of the City Court of Minden and the marshal of the City Court of Springhill
HB 202	RICHARDSON	CRIMINAL/VICTIMS Provides for the confidentiality of crime victims
HB 219	CARMODY	SHERIFFS Provides relative to payment of fines, taxes, and fees to the sheriff and ex officio tax collectors
HB 279	RICHARDSON	CLERKS OF COURT Provides for the powers and authority of certain deputy clerks in East Baton Rouge Parish
HB 294	HAZEL	COURTS/CITY Provides relative to surplus and unclaimed funds in the city courts of Pineville and Alexandria
HB 296	HAZEL	SHERIFFS Amends provisions of law specifying when deputy sheriffs take the oath of office
HB 359	LOPINTO	DISTRICT ATTORNEYS Provides for payment of group health insurance premiums for retired DAs from the 25 th JDC
HB 391	GALLOT	DISTRICT ATTORNEYS Provides for procedures when probation and parole fees are not timely paid
HB 447	THIBAUT	COURTS/COURT REPORTERS Repeals provisions of law providing for special provisions for court reporters for the 18 th Judicial District
HB 532	GALLOT	LAW ENFORCE/OFFICERS Provides for the certification by the Council on Peace Officer Standards and Training of the La. Supreme Court security personnel

HB 599	HILL	COURTS/COURT REPORTERS Authorizes the issuance of a temporary permit for official court reporting
HB 606	PERRY	HOMELAND SECURITY Provides for the prohibition of price gouging after a declared state of emergency
HB 617	TALBOT	HOMELAND SECURITY Provides relative to price gouging during declared state of emergencies
HB 654	BADON, BOBBY	COURTS/COMMISSIONERS Provides for the powers of the office of the commissioner for the Fifteenth Judicial District Court
HB 701	THIBAUT	DISTRICT ATTORNEYS Provides for establishment and maintenance of juvenile justice programs and services
HB 710	ERNST	MILITARY AFFAIRS Provides for various changes to laws governing the administration of the Military Department
