| HB 6 | SMITH, PATRICIA (TBA) | TAX/INCOME-INDIV/CREDIT Increases the Childrens' Education Tax Credit to \$100 (Subject to Rule Suspension) |
| HB 7 | SMITH, GARY (TBA) | TAX/INCOME-INDIV/CREDIT Provides an individual income tax credit based on the expense of health insurance premiums (Subject to Rule Suspension) |
| HB 8 | SMITH, GARY (TBA) | TAX CREDITS Provides for a tax credit for certain small businesses who pay health insurance premiums for their employees (Subject to Rule Suspension) |
| HB 25 | ROBIDEAUX (TBA) | TAX/SALES-USE-EXEMPT Requires a state "sales tax holiday" for certain hurricane-preparedness items or supplies during a state of emergency which has been declared due to a named tropical storm or hurricane (Subject to Rule Suspension) |
| HB 100 | FOIL (TBA) | TAX CREDITS Provides for tax credit for state income and corporate franchise tax for expenses of La. employers' provision of health care benefits to employees (Subject to Rule Suspension) |
| HB 178 | KATZ (TBA) | TAX/SALES & USE Provides relative to the effectiveness of the state sales and use tax exemption for the sale of admission tickets by Little Theater organizations (Subject to Rule Suspension) |
| HB 287 | ROY (TBA) | TAX CREDITS Provides for a credit against individual and corporation income tax for certain employers who pay health insurance premiums for their employees (Subject to Rule Suspension) |
| HB 388 | WHITE (TBA) | ECONOMIC DEVELOPMENT Expands definition of "new direct job" in the Quality Jobs Program Act to include a contractor's employees in certain circumstances (Subject to Rule Suspension) |

HB 463	TALBOT (TBA)	TAX CREDITS Authorizes a tax credit for individuals and corporations which donate to certain school tuition organizations (Subject to Rule Suspension)
HB 473	LITTLE (TBA)	TAX/SALES-USE, STATE Authorizes a state sales and use tax exemption for certain commercial farm irrigation equipment (Subject to Rule Suspension)
HB 482	LITTLE (TBA)	TAX/INCOME TAX Provides an individual income tax deduction for amounts paid on a utility bill for charges for the Louisiana Utilities Restoration Corporation (LURC) (Subject to Rule Suspension)
HB 534	STIAES (TBA)	TAX CREDITS Authorizes a tax credit for the purchase of encapsulating paint used in the remediation of lead-based hazards in residential and commercial structures (Subject to Rule Suspension)
HB 563	BURRELL (TBA)	TAX/AD VALOREM TAX Provides relative to ad valorem taxes (Subject to Rule Suspension)
HB 578	RICHMOND (TBA)	TAX/INCOME-INDIV/EXEMPT Increases tax credits for employment of certain persons related to the prevention of recidivism by persons released from incarceration (Subject to Rule Suspension)
HB 709	GREENE (TBA)	TAX CREDITS Authorizes a tax credit for qualified railroad renewal expenditures (Subject to Rule Suspension)
HB 746	PETERSON (TBA)	INSURANCE/HOMEOWNERS Provides for the reimbursement and payment of or offsetting of assessments levied by Louisiana Citizens Property Insurance Corporation (Subject to Rule Suspension)
HB 818	ELLINGTON (TBA)	TAX/SALES-USE, STATE Phases-in an exclusion from state sales and use taxes for certain tangible property related to the manufacturing process (Subject to Rule Suspension)
HB 861	HARRISON (TBA)	TAX/SEVERANCE TAX Provides relative to the value of oil for purposes of determining the severance tax and the deduction of certain transportation expenses (Subject to Rule Suspension)
HB 874	PETERSON (TBA)	BONDS Authorizes a political subdivision issuing bonds pursuant to the provisions of the American Recovery and Reinvestment Act of 2009 to sell the bonds on a negotiated basis. (Subject to Rule Suspension)
