<b>HB 69</b>	<b>LIGI</b>	<b>RETIREMENT BENEFITS</b> (Constitutional Amendment) Provides for forfeiture of retirement benefits by public officials and employees who are convicted of felony acts associated with their positions
<b>HB 72</b>	<b>LABRUZZO</b>	<b>RETIREMENT BENEFITS</b> Prohibits a public servant convicted of an office-related felony from receiving retirement benefits
<b>HB 73</b>	<b>LIGI</b>	<b>RETIREMENT BENEFITS</b> Requires forfeiture of retirement benefits by any public employee or elected official who is a member of a public retirement system and is convicted of certain state or federal felony acts associated with his office
<b>HB 143</b>	<b>LABRUZZO</b>	<b>RETIREMENT BENEFITS</b> (Constitutional Amendment) Provides for forfeiture of public retirement benefits by certain persons who are convicted of felony acts associated with their positions
<b>HB 224</b>	<b>PEARSON</b>	<b>RETIREMENT BENEFITS</b> Requires suspension of public retirement benefits during incarceration
<b>HB 228</b>	<b>PEARSON</b>	<b>RETIREMENT BENEFITS</b> (Constitutional Amendment) Provides for suspension of public retirement benefits during a member's incarceration
<b>HB 329</b>	<b>PEARSON</b>	<b>RETIREMENT/PUBLIC OFFLS</b> (Constitutional Amendment) Prohibits membership of certain part-time public officials in public retirement systems
<b>HB 330</b>	<b>PEARSON</b>	<b>RETIREMENT/PUBLIC OFFLS</b> Prohibits membership of certain part-time public officials in public retirement systems
<b>HB 515</b>	<b>PEARSON</b>	<b>RETIREMENT SYSTEMS</b> Provides for the organization, governance, administration, and membership of the Funding Review Panel
<b>HB 517</b>	<b>ROBIDEAUX</b>	<b>RETIREMENT/STATE EMPS</b> Relative to the La. State Employees' Retirement System, provides for the employee contribution rate of certain members

- HB 518**     **ROBIDEAUX**                    **RETIREMENT/STATE EMPS** Relative to the La. State Employees' Retirement System, clarifies the definition of "accumulated contributions"
- HB 746**     **ROBIDEAUX**                    **RETIREMENT/STATE EMPS** Relative to the La. State Employees' Retirement System, provides relative to calculation of benefits for persons electing early retirement
- HB 1142**    **ROBIDEAUX**                    **RETIREMENT/STATE EMPS** Relative to the Louisiana State Employees' Retirement System, provides for compliance with qualified plan provisions of the Internal Revenue Code
