Remarks:

<b>HB 45</b>	<b>LAMBERT</b>	<b>FISHING/CRABS</b> Removes requirement for crab trap markers north of the saltwater line
<b>HB 545</b>	<b>BALDONE</b>	<b>FISHING/COMMERCIAL</b> Provides that the commercial season for speckled trout remain open until the maximum annual quota is reached
<b>HB 597</b>	<b>ST. GERMAIN</b>	<b>FISHING/COMMERCIAL</b> Allows commercial fishing for shad throughout the Atchafalaya Basin Spillway
<b>HB 599</b>	<b>ELLINGTON (TBA)</b>	<b>WATERWAYS/LAKES</b> Regulates the use of certain devices on Lake Lafourche in Caldwell Parish ( <b>Subject to Rule Suspension</b> )
<b>HB 641</b>	<b>HENDERSON</b>	<b>FISHING/OYSTERS</b> Repeals the sunset date for the use of devices to prevent predation on oyster leases
<b>HB 642</b>	<b>HENDERSON</b>	<b>FISHING/OYSTERS</b> Adds a member from the Louisiana Oystermen Association to the Oyster Task Force
<b>HB 644</b>	<b>HENDERSON</b>	<b>FISHING/OYSTERS</b> Allows the relocation of certain classes of oyster leases
<b>HB 656</b>	<b>GISCLAIR</b>	<b>WATERWAYS/LAKES</b> Authorizes the Lafourche Game and Fish Commission to govern, regulate, and control Lake Long
<b>HB 692</b>	<b>WOOTON</b>	<b>FISHING/OYSTERS</b> Extends the time within which an oyster lease renewal must be recorded
<b>HB 693</b>	<b>WOOTON</b>	<b>FISHING/OYSTERS</b> Requires DHH to notify oyster harvesters and dealers of a possible state exemption from the National Shellfish Sanitation program's Vibrio management plan
<b>HB 695</b>	<b>WOOTON</b>	<b>FISHING/OYSTERS</b> Allows the sale within the state of La. of oysters for raw consumption at all times of the year
<b>HB 712</b>	<b>WOOTON</b>	<b>FISHING/OYSTERS</b> Provides for certain restrictions on the taking of oysters

<b>HB 875</b>	<b>HARRISON</b>	<b>FISHING/SHRIMP</b> Creates the La. Shrimp Task Force within the Dept. of Wildlife and Fisheries
<b>HB 876</b>	<b>ST. GERMAIN</b>	<b>FISHING/OYSTERS</b> Removes the requirement for payment of a survey fee for oyster leases
<b>HB 887</b>	<b>ST. GERMAIN</b>	<b>FISHING/FINFISH</b> Provides relative to management protocols to be followed by the Dept. of Wildlife and Fisheries for certain finfish
<b>HB 888</b>	<b>ST. GERMAIN</b>	<b>FISHING/FINFISH</b> Provides for identification of certain saltwater finfish
<b>HB 889</b>	<b>ST. GERMAIN</b>	<b>FISHING/OYSTERS</b> Authorizes the Wildlife and Fisheries Commission to promulgate rules to protect oyster habitat from harvest-related damage
<b>HB 890</b>	<b>HARRISON</b>	<b>WILDLIFE &amp; FISHERIES SEC</b> Authorizes the secretary of the Dept. of Wildlife and Fisheries to develop certification standards for Louisiana wild fish and seafood including wild-caught shrimp
<b>HB 953</b>	<b>LAMBERT</b>	<b>FISHING/COMMERCIAL</b> Provides relative to legal finfish possession by commercial crabbers
<b>HB 1288</b>	<b>GUINN</b>	<b>FISHING/DEVICES</b> Allows the use of wire nets and hoop nets for recreational fishing in the freshwater areas of the state
<b>HB 1334</b>	<b>LAMBERT</b>	<b>WILDLIFE &amp; FISHERIES DEP</b> Provides relative to fisheries management by the Department of Wildlife and Fisheries
<b>HB 1346</b>	<b>DOVE (TBA)</b>	<b>WILDLIFE &amp; FISHERIES DEP</b> Provides relative to funding for a La. wild-caught seafood certification program ( <b>Subject to Rule Suspension</b> )
