| HB 274 | POPE | BUDGETARY CONTROLS Provides for the appropriation of funds for the reimbursement of stipends for national certification of certain education employees |
| HB 311 | HARRISON | APPROPRIATIONS Provides funding to the Dept. of Education to implement Act 952 of the 2003 Regular Session relative to speech-language pathologists and audiologists |
| HB 478 | WHITE | FUNDS/FUNDING Dedicates unclaimed property to funding for certain highway construction |
| HB 705 | JACKSON, MICHAEL | PUBLIC CONTRACT/BIDS Requires public entities to give preference to state banks |
| HB 994 | HARRISON | STUDENT/LOANS-SCHOLARSHIP Relative to TOPS, provides, under specified circumstances, for the repayment by a student of an award amount paid on his behalf by the state during the first two award years |
| HB 1005 | HARRISON | INSURANCE/GROUP-STATE Provides for the establishment of a program to address the high rate of obesity in La. |
| HB 1041 | BADON, AUSTIN | APPROPRIATIONS Provides for the annual appropriations for voluntary parish councils on aging |
| HB 1132 | ROY | CONTRACTS Requirements for contracts for the privatization of services for persons with addictive disorders |
| HB 1306 | DOWNS | FUNDS/FUNDING Requires fifty percent of nonrecurring revenues be allocated to the highway priority program |

SCR 39	THOMPSON	RECOVERY AUTHORITY Approves an action plan amendment proposed by the Louisiana Recovery Authority for the Economic Development Infrastructure Program, the State Cost-share Reserves Program, the Interoperable Communications Infrastructure Program, and the Agriculture Program.
SB 57	BROOME	CHILDREN Creates the Council on the Status of Grandparents Raising Grandchildren. (gov sig)
SB 71	APPEL	PUBLIC CONTRACTS Requires state and local contractors to disclose the full disposition, splitting, or sharing of contract commissions, fees, or other consideration by an "affidavit of notice of fee disposition" if the contract is let without bid. (7/1/10)
SB 88	MORRELL	BANKS/BANKING Exempts certain deposits insured or guaranteed by a governmental agency insuring bank deposits that is organized under federal law from security requirements. (8/15/10)
SB 207	MOUNT	HEALTH SERVICES Provides for contracts for fiscal intermediary services in processing claims of health care providers. (8/15/10)
SB 293	DONAHUE	STATE AGENCIES Requires the commissioner of administration and the Board of Regents to establish and implement an agency attrition analysis process. (8/15/10)
SB 471	MICHOT	FUNDS/FUNDING Provides for the deposit and use of certain state treasury funds. (gov sig)
SB 599	GAUTREAUX, B.	COASTAL PROTECT/RES FD Provides in each fiscal year, at least \$200,000 but no more than seven percent of the federal revenues received by the state generated from Outer Continental Shelf oil and gas activity may be used for administrative costs or fees. (8/15/10)
SB 711	CHEEK (TBA)	FUNDS/FUNDING Provides for the Community Hospital Stabilization Fund. (gov sig) (Subject to Rule Suspension)
