<b>HB 459</b>	<b>HARRISON (TBA)</b>	<b>PUBLIC SERVICE COMN</b> (Constitutional Amendment) Provides for changes to the powers, duties, limitations, and processes of the Public Service Commission ( <b>Subject to Rule Suspension</b> )
<b>HB 689</b>	<b>BALDONE</b>	<b>AUCTIONS/AUCTIONEERS</b> Provides for fraudulent practices during an auction
<b>HB 707</b>	<b>HOFFMANN</b>	<b>REAL ESTATE/APPRAISERS</b> Establishes fees for licensure as a real estate appraisal management company
<b>HB 1151</b>	<b>JOHNSON</b>	<b>CONSUMERS/PROTECTION</b> Requires that a notice of recall be given to a prospective buyer prior to the purchase of a new vehicle
<b>HB 1347</b>	<b>DIXON</b>	<b>INDUSTRIAL DEVELOPMENT</b> Provides that airports with industrial parks or land designated for industrial development may apply to be designated as foreign trade zones
<b>HB 1351</b>	<b>NOWLIN</b>	<b>CORPORATIONS</b> Provides relative to the dissolution of electric cooperatives
<b>HB 1372</b>	<b>LEBAS</b>	<b>LICENSING</b> Provides relative to the La. State Board of Home Inspectors
<b>HB 1380</b>	<b>LEBAS</b>	<b>LICENSING</b> Provides for the delinquent renewal of a license issued by the State Board of Home Inspectors
<b>HB 1385</b>	<b>CHANDLER</b>	<b>UTILITIES</b> Provides relative to the use of agricultural waste products as a source of fuel for the production of energy
<b>HB 1402</b>	<b>BURRELL</b>	<b>ECONOMIC DEVELOPMENT</b> Promotes economic empowerment of socially and economically disenfranchised people and businesses
<b>SB 198</b>	<b>DUPLESSIS (TBA)</b>	<b>FINANCIAL INSTITUTIONS</b> Authorizes financial institutions to charge certain fees in connection with motor vehicle transactions. (gov sig) ( <b>Subject to Rule Suspension</b> )

<b>SB 228</b>	<b>DUPLESSIS (TBA)</b>	<b>CONSUMERS/PROTECTION</b> Provides relative to credit reporting security. (8/15/10) <b>(Subject to Rule Suspension)</b>
<b>SB 484</b>	<b>DUPLESSIS (TBA)</b>	<b>BANKS/BANKING</b> Provides relative to payment of dividends or stock by state banks. (8/15/10) <b>(Subject to Rule Suspension)</b>
