Remarks:

<b>HB 985</b>	<b>WHITE</b>	<b>HEALTH SERVICES</b> Establishes the La. Emergency Response Network as the lead agency to govern, develop, and manage a comprehensive statewide trauma system that would address trauma and time-sensitive illness
<b>HR 47</b>	<b>GALLOT</b>	<b>HOUSE/RULES</b> Prohibits a member from changing his vote after the result of the vote has been announced by the presiding officer
<b>HCR 55</b>	<b>MORRIS</b>	<b>LEGISLATIVE AUDITOR</b> Requests the office of the legislative auditor to conduct a performance audit on the postsecondary education system
<b>HB 487</b>	<b>HARRISON</b>	<b>GOVERNMENT ORGANIZATION</b> Provides that the lieutenant governor shall serve as commissioner of administration
<b>HB 496</b>	<b>SMILEY</b>	<b>AGRICULTURE</b> Merges the Fertilizer Commission and the La. Feed Commission
<b>HB 498</b>	<b>TALBOT</b>	<b>GOVERNOR/SUCCESSION</b> (Constitutional Amendment) Relative to vacancies in the office of governor, provides for filling of such vacancies and vacancies created by gubernatorial succession to the office of governor
<b>HB 600</b>	<b>HARRISON</b>	<b>GOVERNMENT ORGANIZATION</b> Abolishes the Department of Health and Hospitals and the Department of Social Services and creates the Department of Health and Social Services
<b>HB 626</b>	<b>BARROW</b>	<b>BOARDS/COMMISSIONS</b> Replaces the composition and membership of all statutorily created boards, commissions, and like entities
<b>HB 743</b>	<b>HENRY</b>	<b>LIEUTENANT GOVERNOR</b> (Constitutional Amendment) Abolishes the office of lieutenant governor, transfers duties to secretary of state, provides for filling vacancies in office of secretary of state and governor
<b>HB 812</b>	<b>HENRY</b>	<b>LIEUTENANT GOVERNOR</b> Abolishes office of lieutenant governor and Dept. of Culture, Recreation and Tourism and transfers powers,

duties, and agencies to executive branch departments


