Remarks:

<b>HB 460</b>	<b>KLECKLEY</b>	<b>INSURANCE/RATES</b> Allows for the use of flex-rating for personal lines property and casualty insurance
<b>HB 511</b>	<b>HARRISON</b>	<b>INSURANCE/HEALTH-ACCID</b> Provides for timely combined medical billing for a single inpatient or outpatient surgery or other medical procedure
<b>HB 512</b>	<b>HARRISON</b>	<b>INSURANCE/RATES</b> Provides that the only credit factor that may be used in determining insurance premiums is that relating to the payment of insurance premiums
<b>HB 698</b>	<b>HARRISON</b>	<b>INSURANCE/AUTOMOBILE</b> Prohibits arbitration or any other type of binding mediation by automobile insurers for certain purposes
<b>HB 1008</b>	<b>HARRISON</b>	<b>INSURANCE/AUTOMOBILE</b> Provides relative to compensating an owner of a vehicle for the depreciation in the value of that vehicle after it has been repaired
<b>HB 1011</b>	<b>HARRISON</b>	<b>INSURANCE/AUTOMOBILE</b> Provides relative to the adjustment and settlement of first-party motor vehicle total losses
<b>HB 1182</b>	<b>GREENE</b>	<b>INSURANCE/HEALTH-ACCID</b> Requires network adequacy of health insurance issuers
<b>HB 1186</b>	<b>GREENE</b>	<b>INSURANCE/HEALTH-ACCID</b> Requires recognition of assignment of health insurance benefits to health care providers
<b>HB 1191</b>	<b>TALBOT</b>	<b>INSURANCE/HEALTH-ACCID</b> Authorizes establishment of an interstate compact governing the sale of health insurance policies and subscriber agreements across state lines
<b>HB 1210</b>	<b>SCHRODER</b>	<b>INSURANCE</b> Provides with respect to the Louisiana Public Adjuster Licensing Law

**HB 1326    ARNOLD**

**INSURANCE/PROPERTY**    Provides for depopulation of the Louisiana Citizens Property Insurance Corporation by domestic insurers via reinsurance

**HB 1328    HARDY**

**INSURANCE**    Requires that the owner of dangerous dog shall maintain liability insurance to redress any personal injury inflicted by the animal

**HB 1360    WOOTON**

**FRAUD**    Amends provisions of law regarding insurance fraud
