

SB 600	MOUNT	MUNICIPALITIES Allows any municipality to prescribe civil fines for the violation of public health, housing, fire code, environmental, and historic district ordinances in the municipality. (8/15/10)

SB 691	WALSWORTH	ECONOMIC DEVELOPMENT Provides for membership of the Northeast Louisiana Film Commission. (8/15/10)
