1. Call to Order and Roll Call.
2. Approval of the minutes, as printed and distributed, and recognition of the results of the legislative balloting with regard to the meeting of the Board held on March 8, 2010.
3. Secretary's Report on the requests to be considered by the Board at today's meeting.
4. APPROPRIATION—A request from the Louisiana Community and Technical College System for \$480,000 to replace the roofs on Buildings No. 2309 and No. 2310 at the Baton Rouge Community College campus.
5. PRIORITY CHANGE IN ACT 21 OF 2010—A request from the Department of Economic Development that \$30 million of the \$65 million in Priority 5 for the Mega-Project Site Preparation, Planning and Construction (05/252-1324 on page 18) be moved up to Priority 2 for the industrial plant project in St. James Parish.
6. PROJECT ALTERATION IN ACT 21 OF 2010—A request from the LSU-Baton Rouge College of Engineering, Renovation and Expansion, Planning and Construction, that the scope of the description of its project (19/601-1446 on page 38 [FPC No. 19-601-00B-04. Part 1]) in the amount of \$5.225 million in Priority 1 general obligation bonds be adjusted according to the provisions of Act 766 of 2001 to allow the replacement of the 30-year-old roof on the Engineering Lab Annex Building using funds in the existing appropriation.
7. PROJECT ALTERATION IN ACT 21 OF 2010 AND ACT 20 OF 2009—A request from the Jefferson Parish Government that the scope of the description of its project (50/J26-336 on page 61 [FPC No. 50-J26-09-05]) of Act 21 of 2010 in the amount of \$50,000 from Priority 1 general obligation bonds for the planning and construction of the Jefferson Community Health Center Expansion to the Existing Marrero Facility in Order to Implement a Dental Program and its project (50/J26-908 on page 66) of Act 20 of 2009 in the amount of \$50,000 in Priority 2 general obligation bonds and \$100,000 in state general fund nonrecurring revenues be adjusted according to the provisions of Act 766 of 2001 to provide for the moving of the project from Marrero on the westbank to River Ridge on the eastbank of the parish.
8. PROJECT ALTERATION IN ACT 21 OF 2010—A request from the District 2 Enhancement Corporation that the scope of the description of its project (50/NBT-1623 on page 115 [FPC No. 50-ML3-08B-09]) in the amount of \$140,000 from Priority 1 general obligation bonds for planning and construction of the New Fence Kingswood Subdivision be adjusted according to the provisions of Act 766 of 2001 to transfer the project to the Kingswood Homeowner's Association, the actual property owner.

9. PROJECT ALTERATION IN ACT 21 OF 2010—A request from the Algiers Development District that the scope of the description of its project (50/NFQ-1213 on page 119 [FPC No. 50-NFQ-09-01]) in the amount of \$1.5 million from Priority 1 and \$1.825 million from Priority 2 general obligation bonds for the planning and construction of the Opelousas Street Extension from Behrman Avenue to Obannon Street and the Patterson Drive Extension from Hendee Street to Obannon Street be adjusted according to the provisions of Act 766 of 2001 to transfer the project to the City of New Orleans, who will be the actual owner of the property.
